Madam,

I am directed to refer to your letter No.12016/3/11-C&LM-1 dated 11/03/2013 on the above subject and to say that views of the Commission on the above proposal of the Government of Tamilnadu intimated to the Ministry vide Commission's letter F. No.TN/Policy/1/2013/RU-IV dated 18/01/2003 clearly support the recommendation of the State Government for inclusion of Narikoravan Community alongwith Kurivikkaran Community since both the communities were synonymous groups. Therefore meaning of the word "alongwith" may not be taken as different from the word "grouped with", since the Commission has nowhere recommended to include Narikoravan as a separate community in the list of Scheduled Tribes in respect of Tamilnadu State.

In view of above, the Ministry of Tribal Affairs is requested to process the proposal further as per prescribed modalities and information about action taken on the views and observations of National Commission for Scheduled Tribes on the subject matter, and the nature and the manner in which these views have been incorporated, may be forwarded to this Commission urgently for including the same in the Annual Report of the Commission.

The 49th meeting of the Commission was held at 13:30 hrs on 19/07/2013 in the Chamber of the Hon'ble Chairperson, National Commission for Scheduled Tribes in the Loknayak Bhawan, New Delhi. The meeting was presided over by Dr. Rameshwar Oraon, Hon'ble Chairperson, NCST. List of the participants is enclosed at **ANNEXURE**. There were Four Agenda Items for discussion in the meeting. Subject: Summary record of the 41st meeting of the Commission held at 12:00 Hrs. on 04-01-2013

The 41st meeting of the Commission was held at 12:00 Hrs. on 04-01-2013 in the Conference Room of the Commission in Loknayak Bhawan, New Delhi. The meeting was presided over by Dr. Rameshwar Oraon, Hon'ble Chairperson, NCST. List of the participants is enclosed at Annexure. There were seven Agenda Items for discussion in the meeting. All the Agenda Items were discussed in the meeting.

MTA vide letter No. 12016/3/2011-C&LM-I dated 26/12/2012 have sought the comments of the Commission on the proposal of the Govt. of Tamil Nadu for inclusion of 'Narikoravan' community by grouping it along with 'Kurivikkaran' community in the list of Scheduled Tribes in relation to the State of Tamilnadu.

19. The Commission noted that the RGI had earlier examined and supported the proposal in 1981 with no objection for Narikoravan being grouped along with Kurivikkaran and treated as Scheduled Tribe as the latter were reported to possess tribal characteristics. The Lokur Committee (1965) and the Joint Committee (1967) had also recommended for inclusion of both Narikoravan and Kurivikkaran in the list of STs of Tamil Nadu. However, the proposal was not processed further as, in 1987, Tamil Nadu Development Federation and later in 2009, the Govt. of Tamil Nadu proposed for inclusion of Narikoravan alone in the ST list of the State though the Study Report had indicated that Narikoravan was

also known as Kurivikkaran. Subsequently, based on the suggestions made by the RGI in 2009, the Govt. of Tamil Nadu agreed for inclusion of Narikoravan grouped with Kurivikkaran in the list of STs on the recommendation of the Expert Committee.

20. The Commission noted that RGI, vide D.O. letter No. 8/1/2007-SS (Tamil Nadu) dated 07/12/2012 addressed to the Joint Secretary, MTA, had mentioned that the standard ethnographic resources on the proposed communities 'Narikoravan' and 'Kurivikkaran' clearly suggested that they were synonymous groups having specific and distinct cultural traits akin to a tribal community of the region. Taking into consideration the recommendation of the Lokur Committee etc. and the views of the RGI in the matter, the Commission recommends for inclusion of Narikoravan community along with 'Kurivikkaran' community in list of STs of Tamil Nadu.
