Proceedings of the Sitting held on 17/07/2017 with the Railway Board under the Chairmanship of Shri Nand Kumar Sai, Hon'ble Chairman, National Commission for Scheduled Tribes in the case of Shri Bharatlal Meena regarding re-medical examination for the post of Assistant Station Master.


List of participants is attached.

During the Sitting, it was informed that in the previous Sitting of the Commission held on 05/07/2017 with the Railway Board on the subject, the parameter adopted in Railways for medical examination in such matters was provided by the Railway Board to the Commission and thereafter the Commission requested the Director, All India Institute of Medical Science (AIIMS) to conduct the required medical test of Shri Bharatlal Meena as per the medical standards of the Railway Board and submit the report to the Commission.

The All India Institute of Medical Science vide their letter No.F-5-3/2015 RPC dated 21<sup>st</sup> September, 2017 forwarded the Medical Examination Report in original in respect of Shri B.L. Meena.

During the Sitting a copy of the Medical Report of the AIIMS was handed over to DG, RHS, Railway Board for his perusal. The DG informed the Commission that they will honour the Medical Report of the AIIMS and appropriate action in this regard will be initiated. The DG has pointed out that the Medical Report of the AIIMS did not have the photo of Shri B.L. Meena. Therefore, Shri B.L. Meena was asked to submit an affidavit stating that he went to the AIIMS for medical check-up and indeed the report is that of him. Accordingly Shri B.L. Meena submitted an Affidavit stating that he approached AIIMS for the test and required test was conducted and this was duly recorded in the AIIMS records, which he has signed also. The Commission accepted that the Medical Examination Report dated 21.09.2017 of AIIMS pertains to the petitioner Shri B.L. Meena.

Given that the premier Medical Institute of the country viz AIIMS have declared Shri B.L. Meena medically fit, the Commission has advised the Railway Board to take immediate step to consider the candidature of Shri B.L. Meena and that an Action Taken Report in the matter is provided to the Commission within a period of fortnight.
