Minutes of sitting held in the Commission on 12/12/2017 at 12:00 Noon under the Chairmanship of Ms. Anusuiya Uikey, Hon'ble Vice-Chairperson, NCST in the case of Dr. Padam Singh Negi, Chief Eye Surgeon, Northern Railway Central Hospital (NRCH), New Delhi regarding frequent and sudden transfers in contravention of existing Ministry of Railways (Railway Board) transfer policy dated 31/08/2015.

A representation dated 25/10/2017 received from Dr. Padam Singh Negi, Chief Eye Surgeon, Northern Railway Central Hospital (NRCH), New Delhi regarding frequent and sudden transfers in contravention of existing Ministry of Railways (Railway Board) transfer policy dated 31/08/2015.


Petitioner's representation dated 25/10/2017 was forwarded to the Chairman, Railway Board and General Manager, Northern Railway vide this Commission's letter dated 01/11/2017 and reminder on 13/11/2017.

In this response, no reply received from the above said authorities.

Therefore, Hon'ble Vice-Chairperson has fixed a sitting with Chairman, Railway Board and General Manager, Northern Railways on 12/12/2017 at 12:00 Noon in the matter. Accordingly, a sitting notice has been issued.

Discussion:

Dr. Anil Kumar, DG, Railway Health Services, Ministry of Railways and Shri Angaraj Mohan, Pr. CPO, Dr. Sunil Kapur, Pr. CMD and Dr. Asha Rani, ACMO, Northern Railway appeared before the Commission on 12/12/2017. Matter discussed in detail. The Hon'ble Vice-Chairperson, Ms. Anusuiya Uikey asked petitioner to his grievance. Dr. P.S. Negi, petitioner has submitted to the Commission that he has been transferred three times within a short span of two years and two months. Now he is further transferred to NCR as CMS vide Railway Board letter dated 14/07/2015 and joined there on 11/08/2015 forenoon. He had an extremely short tenure as CMS, NCR Jhansi for approximately eight months until 13/04/2016. During this very short tenure of 8 months at Jhansi as CMS, Jhansi Division was awarded inter divisional medical Shield which was a prestigious achievement. He was then transferred from Jhansi, NCR to Northern Railway vide Railway Board, Ministry of Railways, Rail Mantralaya vide order No. E(O)III-2015/TR/145(.) dated 17/03/2016. Subsequently, he reported for duty at Northern Railways Headquarters Office on 14/04/2016. Thereafter he was posted as CMS, Delhi Division as on 25/04/2016 and he was again transferred to Northern Railway, Central Hospital vide GMP notice dated 15/02/2017. Thereafter he was transferred to Lucknow on 24/10/2017 at CMS, Lucknow on Administrative ground as junior most SAG Officer without transfer policy.

In response the Railway authority submitted to the Commission that stay of Dr. P.S. Negi in Delhi area is also a longer for more than 30 years being initially appointed as ADMO at NRCH on 17/10/1986 and was still working in Delhi area at NRCH upto 25/10/2017 and relieved to carry out his transfer and to join as CMS/LKO except his short tenure of more than 08 months he worked on NCR as CMS / NCR /JHS. He was transferred to LKO Division being junior most SAG Officer working in the SAG post at NRCH.

The Commission observed that following documents not presented during the sitting by the Railway authority.

1. All relevant transferred records date wise of Dr. P.S. Negi.
2. All PP records of transferred dated 24/10/2017.
3. Records of Junior most SAG is transferred every time as per transfer policy.
4. Records of Administrative period for IRMS Officer as per Gazette Notification.

The Commission advised to the Railway authority that Dr. P.S. Negi should be transferred back to Delhi on first available SAG / Pinpoint vacancy of IRMS / Northern Railway Cadre, fall vacant in Delhi area.

Action Taken Report in the matter may be submitted to this Commission urgently.
