PROCEEDINGS OF SITTING HELD ON 06.03.2018 AT 04.00 P.M. CHAIRED BY SHRI NAND KUMAR SAI, HON'BLE CHAIRPERSON, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) ON REPRESENTATION DATED 17.02.2016 OF SHRI BHAGWAT SHYAMRAO BENDE, (SR. MANAGER, UNION BANK OF INDIA, MUMBAI), MAHARASHTRA REGARDING REINSTATEMENT INTO SERVICE IN UNION BANK OF INDIA.

Date of Sitting: 06.03.2018


List of officers present in sitting is Annexed.

Shri Bhagwat Shyamrao Bende, (Sr. Manager, Union Bank of India, Mumbai), Maharashtra vide representation dated 17.02.2016 had requested NCST for reinstatement into service in Union Bank of India.

2. NCST held a Sitting on 26.04.2017 under the Chairmanship of Miss Anusuiya Uikey, Hon'ble Vice-Chairperson, NCST with the Union Bank of India and petitioner in the matter. In the proceedings of Sitting, Commission advised the petitioner that he would file a mercy petition before the Bank for re-consideration and the Bank Administration may reconsider the petition and informed the Commission on the action taken by the Bank, immediately.

3. Union Bank of India, Mumbai vide letter No. CO:ERD:221:2018 dated 10.01.2018 had furnished the action taken report along with pointwise information as discussed/advised in the Sitting on 26.04.2017. A copy of the order dated 21.12.2017 of Reviewing Authority of Union Bank of India of the petition of Shri Bende was also enclosed with the letter. Reviewing Authority in Order dated 21.12.2017 has mentioned that "in the light of above, the punishment imposed on the petitioner by the Disciplinary Authority and upheld by the Appellate Authority is commensurate with the nature / gravity of lapses held as proved against the petitioner and I find no reason to interfere with the same". The Review Petition preferred by Shri B.S.Bende is, therefore, rejected.

4. In meanwhile, petitioner approached the NCST and demanded for justice. Accordingly, Hon'ble Chairperson fixed a Sitting on 06.03.2018 at 4.00 P.M. to discuss the issue with Managing Director & CEO of Union Bank of India. Managing Director & CEO, Union Bank
