Minutes of sitting held on 30/07/2018 at 12:00 Hours at Circuit House, Gandhinagar (Gujarat) under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Bhupatsingh Vitthalbhai Vasava, R/o Narendra Park Society, Plot No. 2, at Vadiya, Taluk-Nandod, District-Narmada, (Gujarat) regarding compensation of land acquired by the District Administration in 1984.

Representation dated 14/06/2017 received from Shri Bhupatsingh Vitthalbhai Vasava, R/o Narendra Park Society, Plot No. 2, at Vadiya, Taluk-Nandod, District-Narmada, Gujarat regarding compensation of land acquired by the District Administration in 1984.

The matter was taken up with the Secretary, Road and Building Department, Govt. of Gujarat for facts and comments. No reply was received from the concerned authority. Shri H. C. Vasava, Hon'ble Member, fixed sitting on 09/08/2017 for discussion in the matter with the Secretary, Road and Building Department, Govt. of Gujarat. In the sitting CE&AS, appeared on behalf of Secretary, Road and Building Department, Govt. of Gujarat. The CE&AS informed that the matter relates with the Revenue Department, Govt. of Gujarat. In the sitting, it was decided that in a near future a sitting will be convened with the Secretary, Revenue Department, Govt. of Gujarat and the Collector, District – Narmada at Gujarat. The minutes of sitting was issued to Secretary, Road and Building Department on 03/10/2017. In pursuance of decision taken in the sitting, a team of NCST under the leadership of Shri H. C. Vasava, Hon'ble Member, NCST conducted tour from 02/04/2018 to 04/04/2018 to assess the facts and the problems in the matter. The Tour Report was forwarded to concerned authorities including Secretary, Revenue Department and Collector, District – Narmada for furnishing the action taken report on the recommendations, urgently vide letter No. BVV/2/2017/STGGJ/DELAAL/RU-I dated 24/04/2018.


The action taken report on the recommendations made in the Tour Report from 02/04/2018 to 04/04/2018 was not received from the concerned agencies. Hence, the Hon'ble Member fixed a sitting for 07/06/2018 to discuss the matter with the Secretary, Revenue Department, Govt. of Gujarat and Collector, District – Narmada. The Revenue Department and Collector, District – Narmada vide letter dated 05/06/2018 and 06/06/2018 has informed that a "Chintan Shibir" being held on 07, 08 and 09 June at Vadodara (Gujarat) and requested to fixed the another sitting. Accordingly, the sitting was postponed and fixed for 29/06/2018. The sitting notice was issued on 11/06/2018. In the sitting dated 29/06/2018 no one was appeared from the Revenue Department and Collector, District – Narmada.

The Hon'ble Member took it as a serious issue and decided to hold a sitting on 30/07/2018 in Circuit House at Gandhinagar. Accordingly, the notice was issued on 20/07/2018 to Additional Chief Secretary, Revenue Department, Govt. of Gujarat and Collector, District – Narmada to appear in the sitting on 30/07/2018 to discuss the matter. In the sitting, the Secretary (LR), Govt. of Gujarat and Collector, District – Narmada were appeared.

The Hon'ble Member asked the petitioner to explain the grievance and action taken by the District – Administration on the issue. The petitioner informed that the District – Administration is not taking concrete action to redress the problems. The Hon'ble Member asked the authorities to explain the action taken by them on the suggestions made in the tour report in this case. The officers appeared in the sitting informed that they have not received tour report dated 02/04/2018 to 04/04/2018 of the Hon'ble Member in the matter. The Hon'ble Member expressed that it is very strange the tour report not received by the Department and the District Collector, Narmada. A copy of tour report was handed over to the Collector, District – Narmada in the sitting and informed that the tour report also available on the website of the Commission.

After discussions, it was suggested that the point-wise information and action taken / to be taken by the District Administration, Narmada on the recommendations / suggestions made in the Tour Report dated 02/04/2018 to 04/04/2018 of Gujarat State which includes this case, should be sent to the NCST within 30 days from the date of sitting. After receipt of the action taken report / present status from the Collector – Narmada as well as Revenue Department, Govt. of Gujarat, the further course of action will be decided by the Commission.
