

Vasava, Hon'ble Member, NCST in the case of Ms. Sadhna Dilip Patel, Amli, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Amli, Silvassa.

Ms. Sadhna Dilip Patel, Amli, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Amli, Silvassa. The NCST vide letter dated 23/05/2018 referred the representation to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of scheduled tribes of Dadra & Nagar Haveli.

NCST convened the sitting (s) in the matter on 24.05.2018 and 28.08.2018. After discussions in the sitting held on 28.08.2018, the Hon'ble Member suggested / recommended that (1) District Administration (Revenue Department) should place the facts that the petitioner is the real owner of the land before the Principal District and Session Judge, UT of Dadra & Nagar Haveli and concerned authorities (2) The District Administration should also call the facts from the Municipality on the laying of gutter line in the land of petitioner. Action Taken Report in the case should be communicated to the NCST within 15 days. There after the next date of sitting will be decided by the NCST in the matter.


The minutes of sitting dated 28.08.2018 was sent to Administrator, UT of Dadra & Nagar Haveli, District Collector, Silvassa and Superintendent of Police, Dadra & Nagar Haveli, Silvassa vide NCST letter dated 18.09.2018. The response/ action taken report was not received. Accordingly, sitting was fixed on 25.10.2018 which was issued vide NCST notice dated 15.10.2018. The sitting was postponed for 26.10.2018 at 12.30 PM and this information was communicated to the Administrator, Dadra & Nagar Haveli, District Collector, Silvassa and Superintendent of Police, Dadra & Nagar Haveli, Silvassa vide NCST notice dated 22.10.2018.
