
Minutes of sitting held in NCST's Headquarters on 26/10/2018 at 11:45 A.M. ~~onwards~~ under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Luxibhai Govind Lotda, R/o Village – Amla, Dokmardi, Silvassa (Dadra & Nagar Haveli) regarding grabbing of land of Scheduled Tribes.

The above issue was discussed by the NCST in its sitting (s) convened on 24.05.2018 and 28.08.2018. After discussions in the sitting held on 28.08.2018, the Hon'ble Member suggested that the consent of applicants be submitted to the Commission. The present position of appeal filed before the Hon'ble Collector by the petitioner may also be communicated to the Commission within a month from the receipt of the minutes of the sitting.

The minutes of sitting dated 28.08.2018 was sent to Administrator, UT of Dadra & Nagar Haveli, Collector, District- Silvassa and Superintendent of Police, Dadra & Nagar Haveli, Silvassa vide NCST letter dated 18.09.2018. The response/ action taken report was not received from these authorities. Accordingly, Hon'ble Member fixed sitting on 26.10.2018 at 11.45 AM and this information was communicated to the Administrator, Dadra & Nagar Haveli, District Collector, Silvassa and Superintendent of Police, Dadra & Nagar Haveli, Silvassa vide NCST notice dated 15.10.2018.

In response to sitting for 26.10.2018, the Resident Deputy Collector (s) Dadra & Nagar Haveli, Silvassa vide letter No. RD/NCST/Laxi-Govan-Varli/2018/4241 dated 24.10.2018 had communicated that a hearing for further necessary enquiry in the said matter scheduled for 14.11.2018 in the office of Resident Deputy Collector (s) Dadra & Nagar Haveli, Silvassa, and requested for exemption in personal appearance before Hon'ble Member on the sitting dated 26.10.2018. There was no response from the office Administrator, UT of D & NH, office of the Collector, District Dadra & Nagar Haveli and Superintendent of Police, Dadra & Nagar Haveli, Silvassa. The petitioner was present in the sitting on 26.10.2018.
