Sub: Representation received from Shri Veerabhadram Vislavath, I.R.S, Deputy Commissioner of Income Tax, Mumbai, R/o, E-37, Darbanga House, Income Tax Colony, Peddar Road, Mumbai, regarding reinstatement & revocation of Suspension.

Ref: Ministry of Finance, Department of Revenue (CBDT) letter No. C-29016/132/2018-Ad.VI(A) (PART) dated 31.12.2018.

Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. A copy of further representation dated 21.01.2019 of Shri Veerabhadram Vislavath is enclosed for necessary action.

2. Shri Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes has fixed a Sitting in the Commission at New Delhi on 12.02.2019 at 02.00 P.M for investigation/inquiry/ action to be taken in the matter.

3. The Hon'ble Chairperson, NCST has also desired that the petitioner's suspension should be revoked and he should be posted at his previous posting at Mumbai with immediate effect as he was unconstitutionally and illegally suspended. The Chairman, CBDT should also bring an action taken report in this regard at the time of sitting in the Commission.

4. Accordingly, you are requested to appear in person for examination before the Hon'ble Chairperson on the above scheduled date and time along with action taken report, full facts and all relevant original records/documents pertaining to this case. The petitioner may also be advised to be present on the day of Sitting in the Commission.

5. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
