**Minutes of sitting held in NCST's Headquarters on 22/01/2019 at 03:30 P.M. under the chairmanship of Shri Maganbhai Dahyabhai Patel, R/o Ultan Faliya Muktanand Marg, Silvassa regarding restoration of land of Scheduled Tribes.**



Shri Maganbhai Dahyabhai Patel vide representation (s) August 2018 and 23.10.2018 had requested for justice on. (i) Action against the opponent who has put the duplicate signature in sale deed and (ii) Inquiry against Ex- Mamlatdar, D & NH Silvassa for misusing his power in regard to land matter, respectively.

The representation (s) were referred to Administrator, UT of D & NH and District Collector, D & NH for facts and comments on 31.10.2018. The facts and comments from the authorities concerned was not received. Hence, Hon'ble Member had convened the sitting on 28.11.2018 to discuss the matter with the Administrator, UT of D & NH and District Collector, D & NH and petitioner. In the sitting, except petitioner no one appeared from the Administration from Dadra & Nagar Haveli. Further, Hon'ble Member decided to discuss the matter with the concerned authorities and the petitioner in a sitting scheduled for 14.12.2018, which was later scheduled for 17.01.2019, but the sitting dated 17.01.2019 was postponed. The date of sitting was fixed for 23.01.2019 which was also preponed for 22.01.2019.

Meanwhile, the Resident Deputy Collector (S), Dadra & Nagar Haveli letter No. RD/RTS-1/NCST/MDP/2018/4704 dated 27.11.2018 had been received in the Commission in which facts and comments on the issue raised in the representation dated 31.10.2018 of the petitioner were mentioned.

In the sitting held on 22.01.2019, the petitioner was present and no one appeared from the Administration of Dadra & Nagar Haveli and District Collector, D& NH. The petitioner informed that being a poor man unable to bear the expenses of the Advocate to defend the matter and requested to suggest/ direct District Revenue Authorities for resolving the issue at the earliest. Since no officials attended the sitting, the Commission took a serious view for non-appearance of the official.
