Minutes of sitting held in the NCST's Headquarters on 22/01/2019 at 03:00 P.M. onwards under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Ms. Sadhna Dilip Patel, Amli, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Amli, Silvassa.

List of participants is annexed.

Ms. Sadhna Dilip Patel, Amli, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Amli, Silvassa. The NCST vide letter dated 23/05/2018 referred the representation to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of scheduled tribes of Dadra & Nagar Haveli.

NCST convened the sitting (s) in the matter on 24.05.2018, 28.08.2018 and 26.10.2018. In the sitting, the petitioner was present and no one was appeared from the Administration of UT of Dadra & Nagar Haveli. After discussions the Hon'ble Member observed that there was no response from the office of the Administrator, UT of D & NH, office of the Collector, District Dadra & Nagar Haveli and Superintendent of Police, Dadra & Nagar Haveli, Silvassa. Hence, the next sitting should be convened on 28.11.2018 at New Delhi to discuss the matter.

In the sitting convened on 28.11.2018, the petitioner was present. The Resident Deputy Collector (S), Dadra & Nagar Haveli, Silvassa vide letter No. RD/RTS-1/NCST/Sadhna Patel/2018/219 dated 23.11.2018 has informed that the matter was heard by them, and the disputed mutation entry No. 7067 dated 14.12.2009 has been cancelled vide order dated 23.11.2018. Further, Hon'ble Member decided to discuss the matter with the concerned authorities and the petitioner in a sitting scheduled for 14.12.2018, which was later scheduled for 17.01.2019, but the sitting dated 17.01.2019 was postponed. The date of sitting was fixed for 23.01.2019 which was also preponed for 22.01.2019.

Meanwhile, the Suptd. of Police, D & NH, Silvassa vide letter No. DNH/Police/SP/NCST/2018/1455 dated 21.12.2018 has informed that the petitioner (Ms. Sadhna Dilip Patel) refused to give her statement. She informed that her land dispute is sorted out by Mamlatdar, Silvassa and no threat is received by any one.

In respect of sitting on 17.01.2019, the Resident Deputy Collector (S), Dadra & Nagar Haveli, Silvassa vide letter No. RD/NCST/Laxi- Govan-Varli/2018/155 dated 09.01.2019 had informed that due to visit of Hon'ble Prime Minister on 19.01.2019 to D& NH, the Administration will be unable to depute any officials to attend the said sitting.

In the sitting held on 22.01.2019, the petitioner was present and no one was appeared from the Administration of Dadra & Nagar Haveli. The petitioner informed that the opposite party (Shri Yogeshbhai Mohanbhai Patel) has filed an Appeal before the Administrator, Dadra & Nagar Haveli against the order dated 23.11.2018 passed by RDC. In addition to this, a case has also been filled before the Hon'ble Court of the Civil Judge, Dadra & Nagar Haveli, Silvassa by Shri Yogeshbhai Mohanbhai Patel. It was also informed that no relief has been given by the District Administration/ Municipal Corporation in respect of removal of gutter line in the land of the petitioner. The petitioner requested for justice.

After discussions, the Hon'ble Member suggested/ recommended that the UT Administration of D & NH should submit the action taken/ to be taken report for handing over the amount of the land to the petitioner and for removal of gutter line laid by the Municipal Corporation in the land of the petitioner to the NCST, within a month from receipt of the proceedings of the sitting.
