
Shri A. Sudhakar, Sr. Technician/ Track Machines, Office of SSE/TM/SC.Rly/ Vijaywada (D.No. 19-43, Viswasanti Nagar, Yanamala Kuduru, District- Krishna, Vijaywada (Andhra Pradesh) vide representation dated 03.08.2018 has stated that the Railway authority discriminating Scheduled Tribe candidates in the written examination for 25% promotional quota and requested for justice. The NCST took up the matter with the General Manager, South Central Railway, Secunderabad for facts and comments vide letter dated 30.04.2019. The response was not received. Accordingly, the Hon'ble Chairperson fixed the sitting for 15.07.2019 at 04.00 PM to discuss the matter with the General Manager, South Central Railway, Secunderabad and the petitioner.

The General Manager, South Central Railway, Secunderabad vide D.O. No. SR/P-HQ/622/RP/NC(ST) dated 12.07.2019 had deputed PCPO/SCR to attend the sitting. The PCPO/SCR appeared in the sitting and the petitioner was also present.

The Hon'ble Chairperson asked the petitioner to explain the problems. The petitioner informed that the due to improper evaluation of answer sheet for awarding marks for the right answers, the authority declared him fail. The answer sheet requires to be referred to other independent agencies for evaluation, since, answer given by me was correct.

The Hon'ble Chairperson asked the representative of South Central Railway to explain the action taken by their Department in the matter. The representative given a copy of the letter No. SCR/IR-HQ/228/JE/PQ/TMO/VoI.IV dated 11.07.2019 of the South Central Railway and reiterated the facts given in the letter. It was also apprised the issue for irregular evaluation of the answer sheet of all employees, who appeared in the said exam is under investigation by the Vigilance Branch of the Department.

After detailed discussions with the representative of South Central Railway and the petitioner, the Commission recommended that the South Central Railway, should asked the Vigilance Branch of their Department to expedite the matter. Report on the action taken in the matter may be submitted to the Commission within 15 days from receipt of the proceedings of the sitting.
