Representation of Shri Devrang Barkya Lahange and other residents of Village Talasari, Taluka Talasari, Distt. Palghar regarding non-payment of compensation from PGCIL.

A meeting was taken by the Miss Anusuiya Uikey, Hon'ble Vice-Chairperson, National Commission for Scheduled Tribes in Palghar District on 28.06.2019 on the above subject. District Collector, Palghar, officers of PGCIL and the complainants were present in the meeting. The applicant reiterated the submission made by him in his complaint and informed that compensation for the trees was not paid as per the rates decided by Gram Sabha it was paid as per the rates decided by forest department. In many cases, the payment has been made as per the rates decided by Gram Sabha but in case of the applicant, it is not being followed.

The District Collector, Palghar informed the Commission that This issue is also related with Power Grid Corporation of India Limited regarding non-payment of compensation for the damages caused to home, crops, land and trees, due to laying of high tension electric lines by PGCIL. Applicant Devrang Barkya Lahange had submitted application to the Hon'ble Commission and his office received copy of this application from Hon'ble Commission on Dated 6/12/2018. His office called report from Executive Magistrate, Talasari and PGCIL and after going through report of PGCIL Dt.08/01/2019 and Report of Tahasildar Talasari Dt.02/01/2019 & Dt. 28/01/2019, his office had given directions to SDM, Dahanu to call meeting of all concerned for speedy valuation of damaged crops, trees, land etc. He also informed that after going through report of PGCIL and Tahsildar, Talasari following facts are seen:

1. Valuation of crop damages not yet calculated.

2. Applicants namely Devrang Lahange, Vanasha Ghute and Shraavan Govari refused to accept compensation offered by PGCIL.
3. Sadu Baraf accepted compensation of tree damages amounting to Rs.23,099/-.

The District Collector, Palghar submitted that there are some disputes regarding calculation of compensation, therefore, his office has given instruction to SDM, Dahanu to hold meeting of all concerned on top priority.

Hon'ble Vice-Chairperson, NCST directed the District Collector, Palghar to arrange the hearing of the affected persons shortly and after the hearing, to ensure that the grievance is settled as provided under law & rules. The Commission directed him to inform about the final decision taken in this regard within a month's time.
