CHINTHAMAN IVNATE**

MATTER: Grievance of Shri G. Bheema naik, State General Secretary, ST Employees And Officer Welfare Association, Hyderabad regarding non implementation of rule of reservation policy in promotion of sts to the post of section officers by the government of telangana.

2. The Petitioner explained his case and submitted as under:

- (i) The Govt. of Telangana conducted Departmental promotion to the post of Section Officer on 17.06.2016 for 80 vacancies for the panel year 2015-16. Against 80 vacancies the ST quota comes 07 vacancies. However, these ST vacancies were not considered for promotion even though there are available eligible ST candidates.
- (ii) During the DPC proceedings for the year panel year 2015-16, the 8th Roster point earmarked for STs which was carry forward as backlog vacancy for ST one Smt. Nirajakshi was considered and not promoted due to non having foundation training. Similarly, one K. Sammaiah was considered for promotion against panel year 2018-19 and he was also not promoted and these vacancies were filled up from general category.
- (iii) A supplementary DPC was conducted on 31.08.2016 to fill up 10 vacancies for the post of Section Officer. But no ST candidates were considered and promoted even though there were 6 clear cut ST vacancies and availability of eligible ST candidates.
- (iv) Another DPC was held on 26.01.2017 and in which no ST candidates were considered as against 7 backlog ST vacancies.
- (v) Again a DPC was conducted on 30.08.2019 to fill up 98 vacancies of Section officers and out of which only, 5 ST candidates were considered and promoted as against current reservation and 07 ST backlog vacancies of panel year 2015-16.
- (vi) During the panel year 2015-16, 8 ST candidates were eligible to be considered for promotion and out of which 06 ST candidates denied promotion. Similarly, in the panel year 2018-19 out of 06 eligible ST candidates, 05 STs were denied promotion.
- (vii) The Govt. of Telangana has violated the rule of own merit promotion policy which stated that those reserved candidates promoted against unreserved vacancies, should not be counted against reservation point.

3. The Resident Commissioner, Government of Telangana appeared before the Commission and informed that the Government has set up Departmental Committee to sort out the issues and assured that in three weeks' time for process of the promotions will be completed.

The Commission took note of the assurance given by the Resident Commissioner and recommends that the process of promotion for the post of Section Officer, including backlog/shortfall vacancies be completed in two weeks' time and also ask the Government until then not to hold DPCs to fill up in other categories. The Commission asks the Government to send action report in the matter.
