
MINUTES OF SITTING HELD IN NCST'S HEADQUARTERS ON 10/12/2019 AT 03:00 P.M UNDER THE CHAIRMANSHIP OF SHRI H. C. VASAVA, HON'BLE MEMBER, NCST IN THE CASE OF SHRI PATEL NAVINBHAI BABUBHAI, R/O AH-4/44 ANAND NAGAR APTT. NR. AKHABHAR NAGAR, NAVA VADAJ, AHMEDABAD - 380013 REGARDING ALIENATION OF LAND OF SHRI KIKABHAI KAYLABHAI AT VILLAGE SAMARALI IN NAVSARI DISTRICT.

Shri Patel Navinbhai Babubhai, R/o AH-4/44 Anand Nagar Aptt. Nr. Akhabhar Nagar, Nava Vadaj, Ahmedabad - 380013 vide representation dated 31.8.2017 has stated that land of Shri Kikabhai Kaylabhai at village Samarali in Navsari District has been alienated, and requested for to get it back from the encroacher. The NCST took up the matter with the Collector, District-Navsari for facts, comments and action taken report on 04.2.2019 followed by reminder dated 13.5.2019. Response was not received from Collector, District-Navsari. Hence, Hon'ble Member decided to discuss the matter with the Collector District-Navsari and the petitioner to resolve the issue on 10.12.2019 at 03:00 P.M. Notice for sitting was issued on 27.12.2019.

The Collector, District-Navsari vide letter No. L.R/Authorised/Ws.2614/2019 dated 08.12.2019 has deputed the Prant Officer Chikhli District Navsari to appear before the Commission on the day of sitting. The Collector Navsari vide letter No. L.R/GNT/Ws.2614/2019 dated 18.12.2019 has also furnished the facts and comments in the matter along with supporting documents. The documents were in Gujarati Language. The Prant Officer Chikhli appeared before the Commission on the day of sitting and petitioner was also present.


The Hon'ble Member asked the petitioner to explain the grievance and problems. The petitioner informed that the Revenue Department, District Navsari has not taken corrective action as the name of his mother and mother's sisters not recorded in the Revenue record as heirs of Shri Kikabhai Kaylabhai.

The Hon'ble Member asked the Prant Officer, Chikhli to explain the action taken by the Revenue Department of District Navsari. The Prant Officer Chikhli reiterated the facts and comments in the letter No. L.R/GNT/Ws.2614/2019 dated 18.12.2019 of Collector District Navsari. It was also informed that the maternal Uncle (Shri Babubhai Kikabhai) of the petitioner has sold the land of the Shri Kikabhai Kaylabhai, who was the heir of Shri Kikabhai Kaylabhai as per Revenue record. The petitioner can file a criminal complaint regarding false Power of Attorney. If he wants to claim his rights in the land in question, he may approach the Civil Court, who is the appropriate forum.

After detailed discussions with Prant Officer, Chikhli, District Navsari and petitioner, Hon'ble Member recommends that the case may be closed, as petitioner and apposite party belongs to ST community.
