
Minutes of sitting held in NCST's Headquarters on 10/12/2019 at 12:30 P.M. under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Rameshbhai Raviya Lotda, R/o Sayli, Dattupada, Silvassa (Dadra & Nagar Haveli) regarding certification / pucca entry in the land at Village - Amlı, Silavassa.

List of participants is annexed.

Shri Rameshbhai Raviya Lotda, R/o Sayli, Dattupada, Silvassa (Dadra & Nagar Haveli) visited the NCST on 23/05/2018 and stated that Revenue Authority are not issuing certification / pucca entry in the land at Village - Amlı, Silavassa. The NCST vide letter dated 23/05/2018 take up the issue with Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of Scheduled Tribes of Dadra & Nagar Haveli.


The NCST convened the sitting (s) on 24.05.2018, 28.08.2018, 26.10.2018, 28.11.2018 and 22.01.2019 and meeting on 06.3.2019 at Silvassa. In the meeting held on 06.3.2019 at Silvassa, the Distict Collector, Silvassa informed that hearings are necessary for enquiring in the said matter, as, it is a Revenue case, challenging the mutation entries/orders of the years 1976 and it time consuming. However, the Administration will convene the hearing at the earliest, to resolve the issue. The minutes of meeting were circulated on 01.5.2019. The petitioner visited the Commission and informed that no action has been taken by the District Administration in his case and requested for justice. Accordingly, Hon'ble Member decided to discuss the issue on 10.12.2019 with the Administrator, UT of D&NH and District Collector, Silvassa. The sitting notice was issued on 27.11.2019.

The Resident Dy. Collector (S), D&NH Silvassa vide letter No. RD/RTS-II/Varsai-Case/05/2015/5391 dated 09.12.2019 had intimated that due to important and urgent issue of merger of UTs of Daman & Diu and Dadra & Nagar Haveli, the administration is engaged in the preparation for the said merger. Thus, exemption may kindly be granted from appearing personally in the sitting. A copy of the brief of the case was enclosed with the letter. The petitioner was present in the sitting on 10.12.2019 at 12:30 P.M.
