

2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
3. The petitioner stated about grabbing of his land i.e., ST land by non STs and preyed restoration of land in his favour. He further apprised that his land has been illegally was encroached by one Kadir Thevar. The Collector has already passed the restoration order for transferring the land to petitioner. The State Government has not taken any action.
4. The officer of the Department of Revenue, Govt. of Maharashtra informed that the State Government could not take action as the matter is pending in High Court.
5. The Commission recommends for immediate removal of Kadir Thevar from the land as he is not a petitioner in that court case and compliance report be sent to the Commission in 10 days.
