KODURI MEENA KUMARI, NATIONAL PRESIDENT,(WOMEN WING), FORUM FOR SOCIAL JUSTICE, REGARDING REQUISITION FOR FILLING UP OF SC/ST BACKLOG VACANCIES OF MEDICAL OFFICERS IN UNANI & AYUSH DEPARTMENT IN GOVERNMENT OF A.P.

A representation dt: 28.11.2019 was received from Smt. Koduri Meena Kumari, National President (Women Wing), Forum for Social Justice regarding requisition for filling up of SC/ST backlog vacancies of Medical Officers in UNANI & AYUSH Department in Government of Andhra Pradesh. The NCST has issued notices to The Principal Secretary, Health, Medical & Family Welfare, Principal Secretary, General Administration Department and Principal Secretary, Finance Department, Government of Andhra Pradesh, vide file no. KMK/11/2019/STGAP/SEOTH/RU-IV.


Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST decided to conduct a sitting During the official tour program to Vijayawada scheduled on 26.12.2019 with The Principal Secretary, Health, Medical & Family Welfare, Principal Secretary, General Administration Department and Principal Secretary, Finance Department, Government of Andhra Pradesh, In the sitting officials Smt. P Usha Kumari, IAS Commissioner, AYUSH Department, Director, Shri. K. Kishore Kumar, IAS, General Administration, Dr. Purushotham, Additional Director, Homeopathy, Govt. Of AP and Dr. D.C.H.S. Sastry, Inspector, Board of Indian Medicine AYUSH Department, and petitioners attended the sitting.

The petitioner and Doctors from A.P. SC/ST Unani un-employees have appraised the commission with regard to their grievance alleged a conspiracy was hatched to regularize the non SC/ST contract Medical Officers (Unani) in the vacancies which was reserved for SC/STs and these posts are identified and treated as backlog vacancies and also to enquire / investigate under POA and PCR Act against there who are conspired to eliminate SC/ST backlog vacancies in favor of the doctors of other communities.

The Commissioner, Ayush Department, A.P. promised that if there is any lapses in filling up of backlog vacancies they would rectify and issue orders for filling-up of SC/ST backlog vacancies of Medical Officers (Unani) with SC/ST doctors within **15 days** from the date of sitting.

The Commission recommends to consider this matter as special case and further recommended to the Commissioner, Ayush Department to issue notification of SC/ST backlog vacancies of UNANI, which were earmarked for SC/STs. The comprehensive proposal in this regard and action taken report should be submitted by the Commissioner, Ayush Department, Govt. of Andhra Pradesh to the Commission.
