MINUTES OF SITTING HELD IN THE NCST'S HEADQUARTERS ON 17/02/2020 AT 05:00 PM UNDER THE CHAIRMANSHIP OF DR. NAND KUMAR SAI, HON'BLE CHAIRPERSON, NCST IN THE CASE OF SHRI JAGDEEP MINZ, CHIEF OFFICE SUPERINTENDENT, RAILWAY CLAIMS TRIBUNAL (RCT), RANCHI BENCH, RANCHI RAILWAY STATION, RANCHI REGARDING HARASSMENT AND USE OF FILTHY LANGUAGE BY THE MEMBER (TECHNICAL), RCT, RANCHI BENCH.

2. Shri Jagdeep Minz, Chief Office Superintendent, Railway Claims Tribunal, Ranchi Bench, Ranchi Railway Station, Ranchi vide representation dated 14.08.2019 has stated that the Member (Technical), RCT Ranchi Bench abused him and threatened to transfer from Ranchi and suspend. The matter was referred to Chairman, Railway Board and Chairman, Railway Claims Tribunal, New Delhi for facts and comments on 17.10.2019. The Registrar, RCT, Principal Bench, New Delhi vide letter No. RCT/DLI/Ranchi/2013 dated 31.10.2019 has furnished the facts and stated that the allegation levelled by Shri Jagdeep Minz are false. As per procedure, the comments received from Registrar, RCT, Principal Bench, New Delhi was communicated to petitioner for satisfaction on 07.11.2019. The petitioner vide rejoinder dated 15.11.2019 has refuted the facts submitted by RCT, Principal Bench, New Delhi and requested for justice. The rejoinder of petitioner was sent to Registrar, RCT, Principal Bench, New Delhi for further comments on 04.12.2019. The Railway Board vide letter No. 2016/TC(RCT)/5-17/RNC dated 26.12.2019 had intimated that the matter is concerned with the RCT, Principal Bench, New Delhi and informed that the further correspondence in the matter may please be make with the RCT, Principal Bench, New Delhi.

4. The Hon'ble Chairperson fixed the sitting for 17.02.2020 at 05.00 PM to discuss the issue with the officers of RCT, Principal Bench, New Delhi and the petitioner. The sitting notice issued on 31.01.2020.

5. On the day of the sitting, Registrar, Principal Bench, New Delhi and the petitioner appeared. The Hon'ble Chairperson asked the petitioner to explain the grievance and action taken by the Management. The petitioner informed that he has placed under suspension and

transferred from Ranchi to Kolkata Bench on 14.08.2019. His father is still not well and therefore, not in position to join Kolkata. The Hon'ble Chairperson asked the Registrar, RCT, Principal Bench, New Delhi regarding action taken by their Department. The Registrar reiterated the facts submitted to the NCST vide letter No. RCT/DLI/Ranchi/2013 dated 31.10.2019 and letter No. स. रे. दा. अधि./दिल्ली/रांची/2013 दिनांक 23.01.2020 and stated that the petitioner may first joined the duty at Kolkata. Thereafter, the Management will consider the request of petitioner.

6. After detailed discussion with the Registrar, RCT, Principal Bench, New Delhi and the petitioner, Hon'ble Chairperson recommends that the transfer order of petitioner from RCT, Ranchi to RCT, Kolkata be cancelled immediately on humanitarian ground, as he is the only one looking after his father, who is still not well and petitioner will also not feel happy at Kolkata, since the Member (Technical, who retired in September, 2019) belongs from Kolkata. The action taken report in the matter may be submitted to the Commission within 15 days.
