

2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.

3. Dr K S S Naik stated that he was victimized by the present Vice Chancellor, Acharya N G Ranga Agriculture University (ANGRAU) by his arbitrary and vindictive activities against the petitioner for being an ST. He was wrongfully implicated by the VC and following which he was demoted from back date and was forced to pay Rs 10 lakh. The then Board of the University also acted against him in collusion with the VC who is the Chairman ex officio Chairman of the Board. His request for a review by the present Board was also denied. He was also not given the opportunity of inspection and verification of records to defend his case. It was further alleged that earlier record was also opened malign his reputation. He is a renowned scientist who developed 9 varieties of the groundnut seed by which not only the university but the country was immensely benefitted. He was victimized for being ST and requested that a case of atrocity against an ST be registered against the VC. His request for TA for attending the hearings of the Commission was also turned down.

- iii. The Chancellor of the University may initiate an inquiry regarding his eligibility for the appointment as VC, his activities and behavior particularly towards the members of Scheduled Tribes and if found guilty, be removed from his office;
- iv. A case of atrocity may be registered against the VC for victimizing a member of ST community;
- v. The TA may be paid to the petitioner for attending the hearings in the Commission in connection with his petition.
