During the sitting the Authorized Representative of the petitioner stated that the person who is having Nepali origin has been issued Fake Caste Certificate by Mr Niranjana Pujari, who is holding an important Ministry in the Government of Odisha. While the person having Fake Certificate has been arrested and facing judicial process the person who issued the Certificate has not been taken into judicial process. Even if he is an accused he has violated the Rule of Law. No legal action has been initiated against him.

In response, the District Collector who was present in the sitting replied that the service of the person has been terminated as the certificate has been found to be fake. With regard to the criminal action she assured that appropriate reply will be sent by the Superintendent of Police to the NCST.

Hon'ble Member, National Commission for Scheduled Tribes, who chaired the hearing recommended the District Collector & District Magistrate, Subarnapur to file a detailed reply in the matter after due consultation with the Superintendent of Police, Subarnapur. It is also recommended that the Superintendent of Police, Subarnapur to file a detailed reply, legal action in the matter as on date.

Action taken Report after due compliance of the recommendation must be provided to the Commission within 15 days.
