
Minutes of sitting held in the NCST's Headquarters on 15/12/2021 at 04:30 PM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes in the case of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Male Nurse, G.B. Pant Hospital and others regarding injustice with Scheduled Tribes employees working in the Health and Family Welfare Department, GNCTD.

List of participants is annexed.

Representation of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Nursing Officers, G.B.Pant Hospital, New Delhi regarding injustice towards Scheduled Tribes employees working in the Health and Family Welfare Department, GNCTD was received in the NCST. The issue was discussed in the sitting(s) held on 13.10.2017, 20.02.2018, 11.08.2018, 26.09.2018, 05.03.2019 and 12.02.2020 in NCST with the officers of Health and Family Welfare Department and other stakeholders and petitioners. The Hon'ble Chairperson, NCST in the sitting held on 12.02.2020 at NCST recommended that "DPC be convened within 15 March, 2020 to regularize 42 ST candidates. The roster for the post of nurses should also be prepared. The action taken report to be submitted to the Commission at the earliest. The action taken report was not received from Health & Family Welfare Department, GNCTD. The petitioners approached NCST for justice.

Accordingly, the NCST has decided to discuss the issue on 15.12.2021 with the Additional Chief Secretary, Health & Family Welfare Department, GNCTD and petitioners. On 15.12.2021, the Special Secretary Health & Family Welfare Department, GNCTD and other officers appeared before the Commission and petitioners were also present. The officers of Health & Family Welfare Department, GNCTD submitted their department's letter No. F.8(140)/Nursing /H&FW/2017/2150 dated 15.12.2021. It was informed that the process of promotion from the post of Nursing officer to Sr. Nursing Officer may take at-least 2-3 months.

After hearing both the parties, the Hon'ble Member recommends that the process of promotion from the post of Nursing Officer to Sr. Nursing Officer will be completed by Health & Family Welfare Department, GNCTD within two months from the date of sitting. The action taken to be taken may be submitted to NCST before stipulated time. If the process of promotion is not completed, the next sitting at NCST will be held in the month of February, 2022
