1. A Sitting was held in the Conference Room of NCST on 22/09/2016 at 11.00 A.M under the Chairmanship of Hon'ble Vice Chairperson, NCST to discuss the matter as mentioned above.

3. Shri J.K.Dahiya, DGM (HR) and Shri Sanjeev Kaushik , AGM (HR) ,Tata Power Delhi Distribution Limited has attended the sitting without any official authority letter and has requested for exemption of the presence of Chief Executive Officer. Shri J.K.Dahiya replied that in the group of B, C &D, reservation policy/rules are followed. He also explained that ACR are transparent and also available on the website.
