

Sub: Proceedings of the Sitting held under the Chairmanship of Hon'ble Vice Chairperson, NCST, to discuss the case of Shri Gopal Singh, S/o Karm Singh, Upper Tehsildar, Rourkee, Janpad, Haridwar, Uttarakhand regarding harassment and demotion.

1. A Sitting was held in the Conference Room of NCST on 20/10/2016 under the Chairmanship of Hon'ble Vice Chairperson, NCST to discuss the matter as mentioned above.
2. List of participants in the Sitting is attached.
3. Commissioner and Secretary (Revenue) Uttarakhand vide letter dated 3947/R-P-T-N-T/16 dated 19/10/2016 has requested for exemption of his presence and nominated Shri Kamal Singh Dimri, Assistant Commissioner (Revenue), Board of Revenue, Uttarakhand to attend the hearing in his place. Hon'ble Vice-Chairperson allowed the same.
4. Deputy Secretary, NCST has explained the case.
5. During the discussion the Hon'ble Vice-Chairperson asked the petitioner also to present his case, before the commission.
6. Petitioner (Shri Gopal Singh) has explain^{ed} his case and requested for his transfer to Rourkee due to his health problem and also for the fact that he is in the verge of retirement. He also inform^{ed} that he was transferred out of Rourkee without any valid reason.
7. After listening both sides, Hon'ble Vice- Chairperson has recommended that Shri Gopal Singh may be transferred back to Rourkee due to his health problem and also for the fact that he is retiring shortly.

8. Hon'ble Vice- Chairperson has directed that intimation about his tour programme (copy enclosed) to the State of Uttarakhand from 24/10/2016 to 29/10/2016 be communicated to Uttarakhand Govt. and also directed that Chairman of Board of Revenue/Additional Chief Secretary, Uttarakhand and District Magistrate, Hardiwar should meet him in person on 24/10/2016 and inform about the compliance of the Commission's recommendation as stated in para 7 above.
9. Shri Mohan Das (9868212843) Private Secretary to the Vice Chairman will communicate the convenient time of Vice-Chairman in Dehradun to the above Officials so that they can meet the Vice-Chairman accordingly and apprise the position relating to the Action Taken in the matter.
