A representation dated 23-05-2016 was received from Shri Vaeriyo Shatsang, General Secretary, ATSUM requesting the Commission to immediately intervene in the matter of on-going protest in Manipur University by the tribals and to issue strict directive to all the Central Educational institutions located in the state of Manipur as per the Central Educational Institutions Reservations in Admission amendment Act 2012 and adherence to compendium on reservation for the Scheduled Castes, Scheduled Tribes and other backward classes in recruitment to avoid manipulation by the dominant community.

2. The matter was taken up with concerned authorities. Thereafter a hearing was fixed in the Commission by the Hon'ble Vice Chairperson on 23-9-2016 in which representatives from the concerned Departments have attended.

3. It has been reported that the matter is subjudice. Hence no directions could be given. It has been decided to wait for the outcome of the case pending in the Hon'ble Court.
