PROCEEDINGS OF SITTING HELD ON 05.04.2022 AT 12.30 HOURS CHAIRED BY SHRI ANANTA NAYAK, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SMT. MAUSAMI HANSDA, WIOLATE GOPAL CHANDRA MAJHI, MANAGER (GEOLOGY), ODISHA MINING CORPORATION LTD., BHUBANESWAR REGARDING HARASSMENT AND USE OF FILTHY LANGUAGE BY DGM (GEOLOGY), OMC LTD., BHUBANESWAR, ODISHA

Details of the hearing with Commissioner of police, Bhubaneswar, Unit- V, Bidyut Marg, Bhubaneswar-751001 and Chairman, Odisha Mining Corporation Ltd. (OMC), OMC House, Bhubaneswar-751001.

- In this matter, as per direction of Hon'ble Member (AN) SUMMONS dated
   15.03.2022 were issued to the Commissioner of police, Bhubaneswar, Odisha,
   Chairman, Odisha Mining Corporation Ltd., OMC House, Bhubaneswar.
- In this matter, the Commission has accepted the petition of Smt. Mousumi
  Hansda wife of Late Gopal Chandra Majhi, Manager (Geology), OMC on the
  Verbal Abuse by Mr Pattnaik and Mental torture caused to him thereby resulted
  in the death of Mr Majhi.
- Pursuant to the Notice dated 10.10.2019 to the Chairman, OMC, the Commission received reply dated 19<sup>th</sup> November, 2019 by Chief Vigilance Officer of OMC. The reply concluded that the allegations levelled could not be substantiated during enquiry.
- On 4.12.2019 the NCST sought Rejoinder from the petitioner on the CVO reply.
   Smt. Mousumi Hansda re-iterated the allegations and annexed the copy of the FIR. FIR lodged by his wife and case registered in Kharabela Nagar Police Station.
- Then after on 21.05.2021 the NCST issued notice to the Commissioner of Police, Bhubaneswar seeking reply within 15 days. On 06.07.2021 the matter was heard at the Sitting held at NCST, Bhubaneswar. The Commissioner of Police and OMC Authorities were asked to re-enquire the matter.

- Since the Authorities failed to submit reply to the Commission the present sitting at Bhubaneswar has been conducted with personal appearance of the petitioner and the Authorities.
- Authorities on the reasons for delay in submission of reply, the Authorities could not give any satisfactory reply. There is no special tribal cell in the OMC. The Composition of Enquiry Committee don't have any member from tribal community and the Enquiry Officer is not Scheduled Tribe. The petitioner was not provided with a liasoning officer as expected. The Police also has not included the provisions of SC ST (PoA) Act in the FIR and concluded the enquiry without finding anybody guilty.
- The OMC Authorities also stated that service benefits by the OMC has been duly paid to the wife of the deceased. The Police stated that as there were no atrocities, no compensation could be paid to the petitioner.

## RECOMMENDATIONS:

After hearing the Commission recommends the followings -

- The OMC Authorities must re-enquire the matter by duly constituted Enquiry Committee having at least one member from the ST Community.
- A liasoning officer may be supplied to the petitioner at the earliest.
- The Police must conduct a fresh enquiry after inserting provisions of SC ST (PoA)
   Act in the FIR.
- Action Taken Report must be submitted to the Commission within fifteen days.
