Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, on the petition of Subhas Lakra on the grievance related to Ranchi Road, S.H. 10 – Biju Express Highway.


**Date of the sitting:** 11.08.22, 06.00 PM

**Officials present in the sitting:** As per Annexure

- In the present matter, the petitioner states that the villagers got the information that the existing Ranchi Road will be expanded into a four lane road from Litibera village to Lanjibernabad Gyanpali. The middle portion – Dhauraadha to Gyanpali will be revised and new route will be constructed through cultivating Royati lands of village, Dhauaadha, Tanatoli, Raikani, Gyanpali of about 5 km. As this land belongs to the STs, they would lose their livelihood.
  - The Commission issued the notice to the District Collector, Sundargarh, Odisha and sought an ATR within the **15 days** of the receipt of the notice.
  - A Reply was received from the Office of the Sub-Collector and DM, Sundargarh which mentioned that no Detailed Project report has been prepared yet and police had to assist the NHAI officials due to some miscreants. Thereby, the petition is baseless.
  - A reply was also received from the Office of the Superintending Engineer, Sundargarh Division and Engineer in Chief, Bhubaneswar which mentioned that there is no proposal for a four lane road by the Works Department. This road has been declared as NH-1434 and it has to be handed over to the NHAI authority as per the letter No. 26676 but the Project Director has not taken over it yet as the survey is still in progress. Thereby, they requested the Commission to move to the NHAI authority for further information.
  - In response to the summons issued by the Commission, Additional Secretary, Works Department, Odisha appeared before the Commission on 11.08.2022.

- The Commission asked the petitioner to explain the case. He stated that no material impact has happened on the ground till date. However, as a precautionary measure we have informed the Commission about the possible outcomes. The authority addressed the issue personally with the reply and stated that nothing has been materialized on the ground yet. The authority stated that the issue raised in the petition are apprehensive in nature. Moreover, these are related to the jurisdiction of the NHA.
