Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Hyderabad, in the case of Shri Dharavathu Ramadasu, National President, Justice for people Right Forum, Khammam, Telangana regarding no action even after lodging of FIR by Smt. Dharavat Jyothi against P.V. Sathyanarayana Reddy.

The Commission received an online representation dated 01.07.2022 from Shri Dharavathu Ramadasu, National President, Justice for people Right Forum, Khammam, Telangana regarding even after the FIR lodged by Smt. Dharavat Jyothi, W/o Shri Bhukya Saida Nayak, Khammam, Telangana, on P.V. Sathyanarayana Reddy's political financial power, the FIR is likely to be closed down. The petitioner states that victim Jyothi approached the PS several times in regards to an atrocity case and an FIR was also registered. Mr. Satyanarayan Reddy approached the victim and threatened her to take the case back. The Police also closed the case. Mr. Reddy lent INR 50000 to victim's husband who has returned the money with interest. Mr. Reddy is also threatening them stating that he would file a false case against them. The petitioner seeks an appropriate action.

In response to the Commission's notice dated 30.08.2022, the Commissioner of Police, Khammam District vide its letter dated 21.09.2022 has submitted a report. In the report, it has been mentioned that the Assistant Commissioner of Police, Kalluru Division enquired into the matter. The enquiry reveals that the case is completely false and there are financial differences between the alleged accused and the petitioner. The petitioner and her husband taken had taken huge amounts of Rs. 9 lacs and 16 lacs by giving promissory notes and Bank cheques for doing minor contract works. Shri Sathyanarayana Reddy asked to clear the debts, the petitioner and her husband started avoiding the phone calls. Shri Sathyanarayana filed O.S. Petitions in Civil Court vide Nos. 1/2022 and 17/2022 for Rs.16 lacs and 13 lakhs respectively against the petitioner and her husband. The cheques issued by the petitioner and her husband were bounced in the Banks and in that regard NI Act cases were filed against them vide Case. No. 41/2022 and 40/2022 and all the cases are pending with the Hon'ble Civil Court. The petitioner is trying to avoid the debts and has lodged a false petition

in Kalluru PS by taking advantage of their castes using the atrocity Act with an intention to avoid repayment of huge amounts taken. The allegations levelled by the petitioner are false and baseless.

- During the course of hearing, it has been observed that the accused has been threatening and following the petitioner till date. She has been threatened to be implicated in the false case by fabricating documents and promissory notes that he had and showing that he lent the Rs. 9 lakhs and Rs 16 lakhs worth promissory notes. The husband of the petitioner has been attacked in a different district. The Commission is constrained to condemn the inaction and lackadaisical attitude of the Police in ensuring safety and security of the petitioner.
- The version of Police in the facts and circumstances especially when the victim is a tribal lady is not acceptable at all. The police has to track the call details of the accused and promptly act to ensure safety and security to the petitioner and her family members.

After the discussion, the Commission recommends the following-

- The Commissioner of Police, to track the mobile location of the accused and save the petitioner from further humiliation and harassment.
- The Commissioner of Police has to conduct an independent and impartial investigation of the with all angles involved in the case.
- The Commissioner of Police may consider change of Investigation Officer and get the matter re-enquired independently and impartially.

An Action Taken Report with compliance of the Recommendations be submitted to the Commission within 15 days.
