

Whereas a letter dated 28.04.2023 from Shri Naba Kumar Sarania, MP (Lok Sabha) alongwith representation of Bheel Adivasi Parivar, Jalore, Rajasthan has been received by this Commission on the subject cited above and the Commission took Suo Moto Cognizance in this matter and has decided to investigate /inquire into the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India. You are hereby requested to submit the facts and information on the action taken on the allegations / matters to the undersigned within 03 days of receipt of this notice positively by post or by person or by any other means of communication.

2. The report should also contain action taken against arrest of accused, filing charge sheet under provisions of IPC and SC/ST (PoA) Act, 1989, monetary relief and rehabilitation package to the victim family as per Atrocity Amended Rules, 2016 etc.

3. Please take notice that in case the Commission does not receive reply from you within the stipulated time, the Commission may exercise the power of Civil Court conferred upon it under Clause (8) of Article 338A of the Constitution of India and issue summons for your appearance in person before the Commission.
