
**Sub: News item dated 12.12.2023 regarding "seven arrested after woman stripped naked, paraded and assaulted in Belagavi Village".**

**Report of Fact Finding Team  
in  
File Number – NCST/ATY/1555//KA/1/2023/APCR**

**Regarding Stripping of ST woman, parading her Naked and  
tying her in electric Pole in midnight in Vantamuri village in  
Belagavi district of Karnataka on December 11, 2023**

The Commission has come across a disturbing news item published in print and electronic media regarding "Seven arrested after woman stripped naked, paraded and assaulted in Belagavi village".

The incident that took place in the intervening night of Sunday and Monday The Commission took Suo Moto Cognizance of the matter and issued notice to the Director General of Police (DGP), Karnataka, the Deputy Commissioner and the Superintendent of Police, Belagavi, Karnataka seeking facts and comments and Action Taken Report within 3 days.

The Commission has gone through several media reports and decided to make a field visit to assess the ground realities and to ascertain the factual positions of the abominable phenomenon, brutality and administrative action so far in the issue.

Accordingly , National Commission for Scheduled Tribes, New Delhi arrived at Belgavi Airport, at around 08.40 Hours on 16<sup>th</sup> December, 2023, accompanied by Mr R.K. Dubey, Deputy Director, NCST. Mr R.K. Tripathy, Special Rapporteur, NCST and Ms Amrita Solanki, Sr. Investigator, NCST proceeded to Belagavi Circuit House.

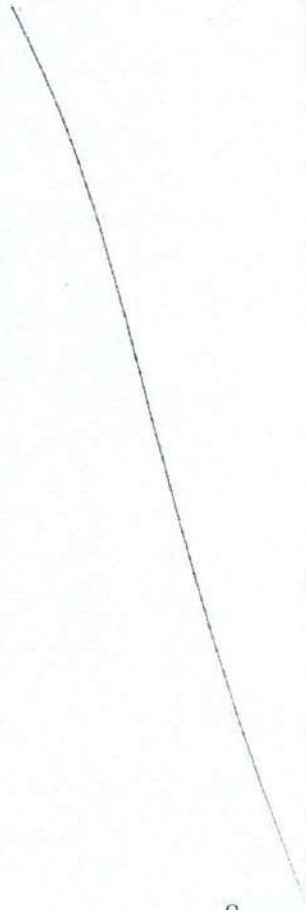
After reaching the Circuit House, Belagavi the team discussed the issue with the Deputy Commissioner, Belagavi and the Commissioner of Police. They apprises the issue and said compensation of five lakhs has been proposed to be paid to the victim by the State Government and another amount of Fifty thousand rupees has been proposed to be paid by the District Legal Service Authority. Land measuring two acres has also been proposed to be registered in the name of the victim. Eleven accused have been arrested and two more are apprehended in the matter. The matter is to be transferred to the Crime Branch of the State for further investigation.

At about 11a.m. the team of the NCST along with the Officials reached the Civil Hospital where the victim is undergoing treatment. Dr A.B. Patil, Dr. Sanjay Karpoor and Psychiatrist Dr. Vijaylaxmi along with some other staffs explained the treatment details. They also handed over the copies of the treatment details annexed herewith as Annexure - 1.

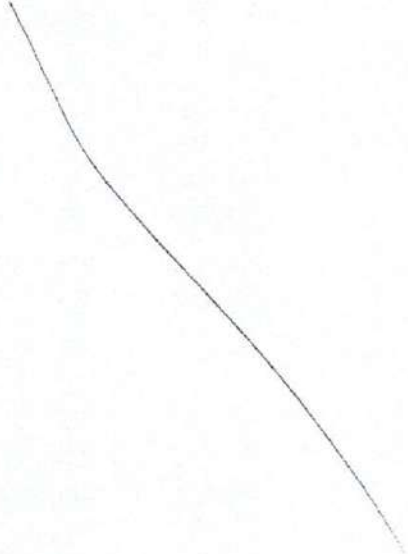
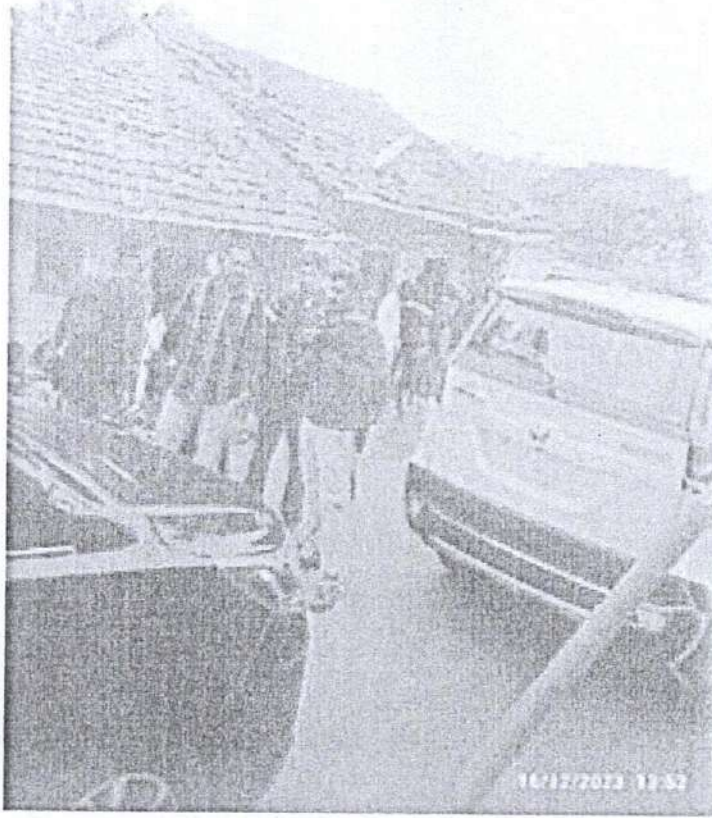
The victim narrated her ordeal in local language. The doctor present there translated her version in English. She stated that a group of people, (the accused) vandalised her house in the midnight and entered her house with weapons, stripped her and paraded her naked. Finally the accused tied her with an electric pole of the village. On the fateful night her husband was not there. Her son was also absent. After the delayed intervention of police she was rescued and being treated in the Hospital. She also stated that she is feeling better after medical treatment and the intervention of the psychiatrist.

After interaction with the victim the Team moved towards Hosavantamuri village, the place of occurrence where the victim and her family members reside. The Investigating Officer (I,O) Mr Girish, A.C.P. (Rural) along with his assistant Police officials accompanied the Team.

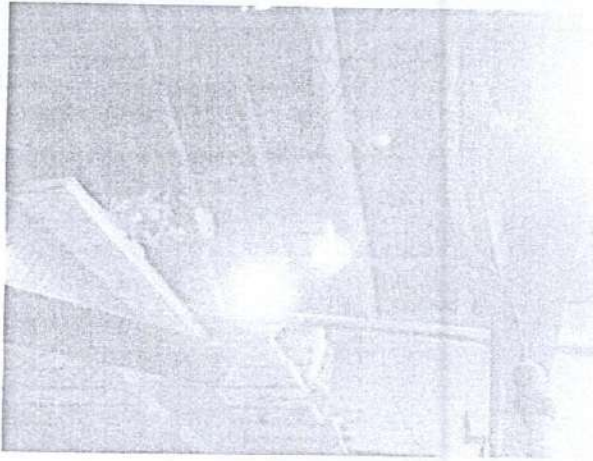
The Police explained the chain of incident. The witnesses, the local inhabitants who seemed to be frightened and tight lipped narrated certain points with request to keep their identity confidential.

Ms Hina Jahangir, wife Mr Jahangir one of the victims, who came to rescue the victim lady stated the veracity, gravity and horrendous activities. She also pleaded for the safety and security of their families.

**Observations** – The crime in the instant case has been committed due to delay in police action. Had there been adequate patrolling and a team of police officials would arrive at the place of occurrence the situation would not have been aggravated so much. Mere suspension of a police inspector seems to be an eye wash. Proper enquiry on the “Police action” will remove the smoky screen on the police action and expose the truth.

It has been informed by the police that the main accused have criminal antecedents like Murder. Had they been convicted or their bail cancelled due their criminal activities as learnt from the neighbours such a heinous act would not have been happened.

Both the accused and the Lady victim belong to ST Community. The person who came to rescue the victim lady, Mr Jahangir, a family friend of the Victim Lady belongs to Minority Community. The district administration including the Police fail to take utmost care of the investigation as apparently visible from the police report. Hina, the wife of Jahangir (another victim) narrated the horror and fear her husband and her entire family suffered on the night of the

incident. Not taking the statement of Jahangir, not treating him as a victim and not considering him for Victim Compensation so far after couple of days proves the inefficacy and incapacibilities of the investigation. The I.O. stated that the State has decided to transfer the case to the Crime Branch. Copy of the documents of such decision could not be supplied to the Team.

The Press has exposed the identity of the victim which is a crime under the provisions of Indian Penal Code.

The Hon'ble High Court of Karnataka has taken Suo-motu cognizance of the issue. Therefore the Commission may not fully act upon the issue as the matter is sub-judice.

In the absence of documentary evidence, it is learnt that the financial and other assurance by the State has not been fructified in sense and spirit.

The following Recommendations may be made for compliance by the State Authorities in the interest of justice : -


1. The D.G.P., Karnataka may be asked to ensure safety and security to the Victims and their family members and also to the witnesses of the case,
2. The D.G.P., Karnataka may be asked to ensure proper legal aid, compensation, psycho-social counseling to the victim. He is also required to expedite the case on top priority,
3. The Chief Secretary may be asked to ensure Land of two acres as promised by the State to the Victim and also to carry out comprehensive survey, the socio-economic status of the entire village inhabited by the Tribals and take corrective measures to curb down the disparities,
4. The Chief Secretary may be asked to ensure concrete road and other basic amenities to the victims village apparently suffering from apathy of administration,
5. The State may be recommended to ensure conviction of the accused in the light of the Judgement of the Hon'ble Supreme Court of India in




6. The Deputy Commissioner has to ensure the health parameters , both physical and mental , of the victims as per the health standards prescribed by the Medical Science,
7. The State administration may take appropriate initiatives for the maintenance of peace and harmony in the Gram Panchayat.
8. Adequate Police patrolling is required for a considerable period of time and confidence among the locals be restored.
9. The damage caused to the house and other household items of the victim has to be compensated and corrective measures be taken for future course of action.
10. Steps may be taken to prevent the identity of the victims not made public.


