Minutes of Meeting held on 09.02.2024 Chaired By Shri Ananta Nayak, Hon'ble Vice-Chairperson (Acting), National Commission for Scheduled Tribes (NCST) in the case of Ms. T.Meha, Gurgaon regarding harassment, misbehaviour, threat and use of abusive language against senior citizen and an ST lady from North Eastern State.

Date of Meeting: 09.02.2024

A representation received through E.mail dated 26.07.2023 from Ms. T.Meha, Gurugram regarding harassment, misbehaviour, threat and use of abusive language against senior citizen and one ST lady of North Eastern State by the Estate Manager Office, Ansal Heights, Section 92, Gurugram. She alleged that she and her husband had gone to the Estate Manager's office, existing compound of Ansal Heights, Sector - 92, Gurgaon to verify about an annual payment. Shri Mohan Brar, GM Maintenance, Shri Praveen Mishra, Accountant and two other individuals harassed and misbehaved, threatened and used abusive language against them. The Petitioner lodged complaints with the Commissioner of Police, Gurugram on 21.02.2023 and 26.05.2023, but no action was taken by the Police.

2. The Commission took up this matter with the Commissioner of Police, Gurugram vide notice dated 07.08.2023.

3. In response to NCST Notice dated 07.08.2023, the Dy. Commissioner of Police (West), Gurugram forwarded a reply/report dated 03.10.2023 wherein it was mentioned that during the investigation of the complaint, no truth has emerged in the allegations of harassment and threats made by the complainant and the employees of Police Post 93, nor has any cognizable offence been committed.

4. Earlier a sitting was held on 30.10.2023 under the Chairmanship of Hon'ble Member, NCST. The Commission recommended that:

- The petitioner belongs to Scheduled Tribe community, hence an FIR should be registered under the appropriate sections of SCs/STs (PoA) Act and other Acts on the basis of the allegations levelled by the petitioner and proper investigation/inquiry be conducted by the Police authorities.
- The petitioner has to provide all evidences available with her to the Police Officer investigating the complaint. The inquiry officer shall complete the inquiry within the period stipulated under the SCs/STs (PoA) Rules.
- Police protection may be provided to the petitioner's family till the completion of investigation.

5. Minutes of the Meeting was forwarded to the concerned authorities on 08.11.2023.

6. In response to the Commission's letter dated 08.11.2023, an action taken report dated 04.12.2023 received from the Commissioner of Police, Gurugram and reported that the Assistant Commissioner of Police, West, Gurugram investigated the matter and case No. 741 dated 27.11.2023 under Section 420,506 IPC 3(1) (9) 3(1)(s) SC&ST Act has been registered at Police Station Sector 10A, Gurugram. As the fact emerge in the case, action will be taken as per the rules. Therefore, no other action is required in the complaint.

7. A copy of ATR dated 04.12.2023 forwarded to the petitioner on 23.01.2024. Further representations dated 29.01.2024 and 31.01.2024 has been received from the petitioner through E.mail.

8. On examination of action taken report of Commissioner of Police, Gurugram, the Commission fixed a Meeting on 09.02.2024 with the Commissioner of Police, Gurugram.

9. On behalf of the Commissioner of Police, Gurugram, the DCP (West) and ACP (West), Gurugram appeared before the Commission. The petitioner was also present in the Meeting.

10. The matter was discussed in detail. The petitioner submitted before the Commission that she belongs to the Scheduled Tribe community from Arunachal Pradesh. After intervention of NCST FIR was lodged. She has not got justice from Gurugram/Haryana Police. Such harassment and apathy against ST community from the North East, their community feels unsafe when their daughters/sisters try to establish themselves in NCR Gurugram.

11. The DCP (West), Gurugram submitted before the Commission that the Assistant Commissioner of Police, West. Gurugram has investigated the matter and case No. 741 dated 27.11.2023 under Section 420,506 IPC 3(1) (9) 3(1)(s) SC&ST Act has been registered at Police Station Sector 10A, Gurugram. As the fact emerge in the case, action will be taken as per the rules. Therefore, no other action is required in the complaint.

12. After hearing the matter, the Commission recommends that:

- In the light of facts being submitted by Smt. Meha, the ACP may re-examine the case.

Action taken report may be submitted to the Commission within 30 days.
