Whereas a Petition / Complaint has been received by the National Commission for Scheduled Tribes from Shri Nabor Ekka dated 15/12/2015 and to say that the matter was taken up with the Delhi Subordinate Service Selection Board vide this Commission's letter dated 19/01/2016 (copy enclosed). In response to the above letter of the Commission, there is no Action Taken Report was received from the Delhi Subordinate Service Selection Board. A copy of reminder has been sent to the Chief Secretary, Govt. of NCT of Delhi and Secretary, Delhi Subordinate Service Selection Board. As desired by former Hon'ble Vice Chairman, a preliminary meeting has been taken by the Director, NCST with the Deputy Secretary, Health & Family Welfare Department on 29/08/2016. No satisfactory Action Taken Report submitted to the Commission. Therefore, Ms. Anusuiya Uikey, Vice Chairperson, NCST has desired to discuss the matter **in person** with you and accordingly fixed a sitting on **13/10/2017 at 2:00 P.M.** in the Commission at Conference Room, 6<sup>th</sup> floor, Loknayak Bhawan, Khan Market, New Delhi for investigation / inquiry / action taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India. You are also hereby requested to submit the facts and information with details on the day of sitting.

Please take notice that in case you do not attend the Sitting with details, the Commission may exercise the powers of Civil Court conferred on it under Article 338A of the Constitution of India and issue summons for your appearance in person or by a representative before the Commission. It is therefore requested to kindly make it convenient to attend the Sitting in the Commission on the Scheduled date and time with all relevant records in the case. The petitioner may also be asked present on the day of Sitting in the Commission.
