Minutes of the Sitting chaired by Shri Jatothu Hussain, Hon'ble Member, NCST on 23.07.2024 in the case of Smt. Yenki Das, C/o Makhanlal Das, R/o Vill. & PO Bokboki, P.S. Kadamtala North Tripura, Dharmanagar, Tripura.

A representation dated nil was received in the Commission from Smt. Yenki Das, C/o Makhanlal Das, R/o Vill. & PO Bokboki, P.S. Kadamtala North Tripura, Dharmanagar, Karnataka, wherein it was stated that her husband late Shri Jayanta Das, had been working in W.T.C. Golden Stone, Samsung, Bangalore. Suddenly, on 03.10.2022 night she received a phone call that her husband was murdered at Bangalore and his body is lying in Silicon City Hospital-Hoskote, Bangalore. She also alleged that she is not in a position to bear the cost of transportation of the dead body from Bangalore to Tripura. He requested the Commission to intervene the matter.

2. Commission issued Notice to the Commissioner of Police, Bangalore, Karnataka on dated 21.10.2022 for ATR/Reply within 15 days.

3. In response to Commission's Notice dated 21.10.2022, a reply dated 20.12.2022 was received from the Commissioner of Police, Bangalore, Karnataka and the reply was forwarded to the petitioner but no any rejoinder received from the petitioner. The Commission fixed a Sitting earlier on 16.10.2023 but, exemption was requested from Commissioner of Police, Bangalore, Karnataka. Another hearing was fixed by the Commission on 23.07.2024 with the Commissioner of Police, Bangalore, Karnataka.

4. On behalf of the Commissioner of Police, Bangalore, Karnataka, The Asst. Commissioner of Police, Whitefield, Bangalore, Karnataka was present in the Sitting. The petitioner Smt. Yenki Das was not present in the Sitting.

5. The matter was examined in detail. The Asst. Commissioner of Police, Whitefield, Bangalore, Karnataka presented details of the case before the Commission. He informed the Commission that his accident was happened while he was going to office and Head Constable himself complained regarding the accident. He also informed that due non availability of his family members, police authorities handed over his dead body to his friend after getting nod from District Magistrate of his hometown.

6. After hearing the matter, the Commission recommends that:

- * Benefits of Social Welfare Schemes should be provided to the petitioners family as per eligibility.

Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 09.07.2024 in the case of Dr. M.Sankar Rao, Sujathanagar Pendurthi, Visakhapatnam Andhra Pradesh.

A representation dated 23.06.2022 of Dr. M.Sankar Rao Sujathanagar Pendurthi, Visakhapatnam Andhra Pradesh was received in the Commission, wherein it was stated that police officers from Pendurthi Police Station entered his house at midnight 3:45 AM and harassed his family. They conducted surveillance twice in his house, asked the petitioner to sleep on the first floor. They trespassed without a lady police officer in regards to a rape case which occurred in their colony for which they wanted to inquire. Petitioner complained the Commissioner of Police, Vishakhapatnam, which was forwarded to ACP and then to SHO (who is one of the accused) but no action was taken. The petitioner was rather threatened. Petitioner requested the Commission to intervene in the matter.

2. Commission issued Notice to the Superintendent of Police, District Visakhapatnam city, Andhra Pradesh on dated 15/09/2022 for ATR/Reply within 15 days.

3. A reply dated 29.05.2023 received from Commissioner of Police, Visakhapatnam city, Andhra Pradesh, wherein it was stated that inspector neither entered in the petitioner's house nor violated his human rights. In this regarding the Commission fixed a Sitting on 09.07.2024 with the Superintendent of Police, Visakhapatnam city, Andhra Pradesh.
