Minutes of the Hearing chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 23.08.2024 in the case of Ms Banothu Lakshmi, D/o Shri Dwalu, Khammam R/O H.No. 4-118/1, Aliya Thanda, Usirikayalapally village, Singearenni mandal, District Khammam, Telangana.

The Commission received a representation dated 06.11.2023 from Smt. Banothu Lakshmi in which she complained that his neighbour is blocking the road and creating problem in supply of drinking water, electricity and other essentials to reach his house by blocking the ways.

2. The Commission sent a Notice to The Commissioner of Police, Khammam, Telangana, on dated 22/12/2023 for ATR/Reply within 15 days.
3. In response to Commission notice dated 16.08.2024 a reply was received on 19.01.2024 from The Commissioner of Police, Khammam. Thereafter, a hearing was scheduled on 23.08.2024.
4. The Commissioner of Police, Khammam, appeared before the commission in person. Petitioner Smt. Banothu Lakshmi and her husband were also present in the hearing.
5. The matter was examined in detail. The Commissioner of Police, Khammam presented details of the case before the Commission. It was submitted by The Commissioner of Police, Khammam that wrong demarcation of land is the main dispute in the case and that the Commissioner shall call both the parties and settle the dispute at the earliest i.e. preferably within a period of 15 days.

6. After hearing the matter, the Commission recommends that:

- Revenue Department of district to demarcate the land in presence of District Collector.
- Strict action to be taken against the miscreants causing hardship to the complainant/petitioner.
- The damages caused to the petitioner by the opponents to be recovered from them and the petitioner to be compensated.
- All the false cases filed by the opponents on the petitioner are to be closed at the earliest.
- Stringent action shall be taken on those trying to encroach the lands of the Tribals which were protected as per provisions of Land Transfer Regulations under the 5th Schedule of the Constitution of India.
- The petitioner to be given protection to avoid any kind of disturbance from miscreants.

Action taken report may be submitted by District Collector, Khammam and Commissioner of Police, Khammam to the Commission within 30 days.
