Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 15.10.2024 in the case of Shri M Mallaiah, President, Telangana ST Employees Welfare Association, 74, HIG phase 3, Annamayya Enclave, BHEL Ramachandrapuram, Hyderabad, Telangana regarding burning of huts by some anti- social elements in Chadarghat, Telangana.

- 1. A representation dated 02.01.2022 was received n the Commission from Shri M Mallaiah, President, Telangana ST Employees Welfare Association, Telangana. He alleged that on 31.12.2021, some anti- social elements have burnt 40 huts of tribal people at Chadarghat, Hyderabad. Due to this, the victim ST families become homeless and they have no livelihood source. The petitioner has requested the Commission to issue necessary directions for action taken against accused, rehabilitation of victim ST families, compensation and providing residential and agriculture land. He requested the Commission to intervene in the matter.
- 2. The Commission issued Notice to the Director General of Police, Telangana, District Collector, Ranga Reddy, Telangana and Commissioner of Police, Hyderabad City, Telangana on dated 05.01.2022 for ATR/Reply within 03 days.
- 3. In response to Commission's notice dated 05.01.2022, a reply dated 07.01.2022 was received from Commissioner of Police, Hyderabad City, Telangana. wherein it was mentioned that fire was broke out accidently while a 75 year old lady was cooking food, So all other huts caught the fire and burnt completely. Because of taking prompt action by the Police authorities, no casualty was reported. Earlier a Sitting was held on 10.02.2022 before the Commission and some unsolved issues were raised in the Sitting. An another Sitting was held on 22.08.2024.

After hearing the matter, the Commission had recommended as given below:

- To enhance the compensation of Rs. 6000 (which as per the submission of the ld. Law officer has already been paid to the affected parties) to Rs. 3-5 Lakh for each affected family.
- To decide on the aspect of allotment of pucca houses to the 16 affected families as mentioned by the Ld. Law officer.
- To submit the list of affected parties with all particulars along with the compensation so awarded up to date in a systematic manner.
- The minutes of the Sitting was forwarded to the concerned authorities.

However, No Action taken report was received in the Commission in the stipulated time. Therefore, the Commission fixed another Sitting on 15.10.2024.

- 4. The Revenue Divisional Officer, Hyderabad District, Telangana was present in the Sitting. The petitioner Shri M Mallaiah was not present in the Sitting.
- 5. The Revenue Divisional Officer, District Hyderabad, Telangana presented details of the case before the Commission.
- After hearing the matter, the Commission recommends that:
 - All the recommendations of the Commission made during the earlier sitting held on 22.08.2024 and communicated vide minutes dated 02.09.2024 to be complied.
 - The District Collector shall attend to the next scheduled date of Hearing.

Report in this regard to be submitted to the NCST within 30 days time-frame.
