Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 15.10.2024 on the representation of Shri Dharavath Chandra Shekhar, Village Gopya Naik Thanda, Devarauppula Mandal, District-Jangaon, (Telangana) regarding fraudulently transfer of land by land mafia with help of Revenue Officials.

Date of the Sitting : 15.10.2024, 11:00 A.M.

Commission has received a complaint in which the petitioner has alleged that his wife is land owner of 15.12 acres land in Survey No. 371, 551. The land mafia and non-ST persons have illegally transferred 6 acres land fraudulently in October, 2008 with the help of Revenue Officials. In this regard, he has lodged an atrocity case against Non-STs at Devarauppula Police Station. But, the police did not take any action against accused and on the other hand, the Police officials have registered a false FIR No. 43 of 2007 and FIR No. 99 of 2020 against him on false allegation made by the accused persons.

2. The Commission took up the matter with the Chief Secretary, Government of Telangana, The Director General of Police, Telangana Police, the District Magistrate, Warangal, Telangana and The commissioner of Police, Warangal, Telangana vide notice dated 01.02.2021 and dated 30.03.2021 for furnishing factual report and comments within 15 days.

3. In response to Commission notice the Director General of Police, Telangana Police furnished report dated 17.04.2021 in which the DGP, Telangana has reported that the matter was inquired by the Commission of Police, Warangal and as per their report it appears that there was a dispute in between the petitioner Shri D. Chandra Sekhar and some other persons relating to land matters. The disputed land was private in nature and there is no atrocity against STs. Police have claimed they have lodged case against petitioner because of their force occupation of land which do not belong to them.

4. The Commission didn't find the action taken report from the police authority satisfactory and decided to conduct a sitting with the District Magistrate, Warangal, Telangana and The commissioner of Police, Warangal, Telangana.

5. The DCP, West zone, Jangao, Warangal Commissionarate was present in the sitting. The petitioner was participated through video conference
6. A detail investigation progress was presented by The DCP, West zone, Jangao, Warangal Commissionarate in the matter and provided information regarding the dispute. The matter was heard in detail.
7. After hearing, the Commission recommends the following and suggested submitting Action taken report within 30 days after receipt of the report, the further course of action will be decided by the Commission.
 - Thumb impression which the petitioner alleged to be forged on the document shall be sent to the forensic laboratory to examine it genuineness and send a report.
 - Field visit to be made by the RDO Jangaon, DCP, Jangaon and enquire the local elders and also obtain the actual status/ facts from the Gram Sabha and submit report.
