Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 15.10.2024 in the case of Smt. Banoth Amala, W/o Shri Rama Koti Naik, R/o Dharavath Thanda, Devaruppula Mandal, District Jangaon, Telangana regarding land matter.

1. A representation dated 10.05.2022 was received in the Commission from Smt. Banoth Amala, W/o Shri Rama Koti Naik, Dharavath Thanda Devaruppula Mandal, District Jangaon, Telangana regarding atrocity, caste abuse and encroachment of ST land and inaction by police authority against accused.

It has been alleged that she had purchased 600 sq house through the registered sale- deed document No. 5524/2019 and 5525/2019 dt. 03.04.2019 of survey number 87/2 under the Municipal Limits of Jangaon district located at Suryapet Road. Thereafter, She started construction of house on 15.9.2019. At that time, some non ST person have obstructed the construction of building and abused her and her family members. They had also beaten her husband. In this regard, she lodged a complaint at local police station on 12.10.2020. But police did not take any action against accused till date. She requested to take action against the accused.

2. The Commission issued Notice to the Commissioner of Police, District Warangal and Deputy Commissioner of Police TS Police, Jangaon West Zone Telangana on dated 08.06.2022 for ATR/Reply within 30 days.

3. In response to Commission's notice dated 08.06.2022, a reply was received from the Deputy Commissioner of Police, Jangaon West Zone, wherein it is stated that the case has lack of evidences and the said land belongs to the accused as well so, there is a case filed in the court for the said land matter. In response to the letter the petitioner filed a rejoinder and he is not satisfied with the authority report. In this matter, the Commission fixed a Sitting on 15.10.2024 with the Commissioner of Police, District Warangal , Deputy Commissioner of Police, Jangaon West Zone Telangana and the petitioner.

4. The Deputy Commissioner of Police, Jangaon West Zone Telangana was present in the Sitting. The petitioner Smt. Banoth Amala was also present in the Sitting.
5. The matter was discussed in detail. The Deputy Commissioner of Police, Jangaon West Zone, Telangana presented details of the case before the Commission.
6. After hearing the matter, the Commission recommends that:
 - The wrong registration happened because of the sellers.
 - The sellers of the land shall be made responsible and it may be ensured that they give land or return back money along with the interest to the petitioner.
 - The DCP shall take it as a special case and consult both the parties and resolve it at the earliest.
