A complaint dated 03.09.2024 received in the Commission from Shri Dilip Chakma, Social activist & Advocate, New Delhi. In the complaint it was alleged that 4 chakma tribal youths named Shri Buddha Ranjan Chakma, 3 others went to Bangalore in search of job for livelihood, Where they met with Manager and Supervisor of Shri Krishna Enterprise (a company based in Hosur, Tamil Nadu), The Manager took them to Bedrapalli in Hosur on 19.08.2024, when they visited the place of work they didn't like the work consequently manager beaten and locked up them forcefully. They also forcibly took ₹36,500 via UPI and confiscated ₹3500 in cash from the victim.

- 2. The Commission took up the matter with Director General of Police, Government of Tamilnadu, District Magistrate, Krishnagiri (Tamil Nadu) and Superintendent of Police, Krishnagiri (Tamilnadu) vide notice dated 05.09.2024 for furnishing facts and comments within 15 days.
- 3. In response to Commission's notice the Director General of Police, Tamilnadu furnished report dated 22.09.2024 in which the authority provided some information regarding arrest and recovery of money from culprit. Police authority also promised to provide SC/ST compensation after submission of Community Certificate by victims.
- 4. The Commission didn't find the action taken report from the police authority satisfactory and decided to conduct a sitting with District Magistrate, Krishnagiri (Tamil Nadu) and Superintendent of Police, Krishnagiri (Tamilnadu)
- 5. The Deputy Collector, Krishnagiri on behalf of the Collector and Superintendent of Police, Krishnagiri were present in the sitting. The petitioner Shri Dilip Chakma, Advocate was also present with Smt. Miloni Chakma.

- 6. A detail investigation progress was presented by Krishnagiri Police authority in the matter and provided information regarding compensation have been paid to the victims, arrest of culprits and seizer of money and mobile phone which was involved in the crime.
- 7. After hearing, the Commission recommends the following and suggested submitting Action taken report within 30 days after receipt of the report, the further course of action will be decided by the Commission.
 - Only 3 culprits involved in this incidence were arrested. The remaining needs to be traced immediately and punished accordingly.
 - It shall be ensured that no such incidences occur in future.
 - · The authorities responsible for the delay to be punished
 - The compensation to the victims to be released in time.
