Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 15.10.2024 in the case of Shri B. Krishna Naik, S/O Late Shri B. Rama Swamy Naik, Trained Graduate Teacher, Dr. B.R. Ambedkar Gurukulam School Quarters No. 6, Sagileru Y.S.R. Kadapa District, Kadapa, Andhra Pradesh regarding physically assault by mob.

1. A representation dated 23.03.2024 was received in the Commission from Shri B. Krishna Naik, Y.S.R. Kadapa District, Andhra Pradesh regarding assault, manhandling him and his brother and foisted a false criminal case No. 1/2020 of West Police Station, Tirupati - demanding for action against erring Police persons. He alleged that he and his brother had gone to Tirupati on 03.01.2020 along with salary certificate to give his brother's solvency before the Hon'ble III Addl. Judicial Magistrate Court Tirupati. The Hon'ble Court pleased and granted bail to his brother in Cr. No. 331/2019 of M.R, Palli Police Station and accepted the petitioner's solvency certificate. They came out of the Court after completing the procedures. Suddenly a mob of nearly 10 persons headed by Inspector of Police hastily manhandled and dragged them to road in front of the Court gate from Court premises. They behaved cruelly beating them with hands and legs, threw them on ground, picked up his brother and pushed into jeep and took him away. Then the petitioner reached the M.R. Palli Police Station, the police again beat him cruelly and scolded him abusively and produced him before D.S.P., West Sub-Division, Tirupati. He requested the Commission to interfere in the matter and requested to action against erring Police persons.


2. The Commission issued Notice to the Superintendent of Police, District Tirupati, Andhra Pradesh on dated 22.05.2024 for ATR/Reply within 15 days.

3. In response to Commission's notice dated 22.05.2024, no reply was received. In this matter the Commission fixed a Sitting on 15.10.2024 with the Superintendent of Police, District Tirupati, Andhra Pradesh and the petitioner.

4. The Sub-divisional police officer District Tirupati, Andhra Pradesh appeared in the Sitting. The petitioner Shri B. Krishna Naik didn't appear in the Sitting.
5. The matter was discussed in detail. The Sub-divisional police officer District Tirupati, Andhra Pradesh submitted details of the case before the Commission.
6. After hearing the matter, the Commission recommends that:
 - There is no corroborative material evidence produced by the petitioner to substantiate his allegation.
 - No documentary proof/ material record is produced.
 - The Commission suggests that the Petitioner may be counselled and case may be closed.
