Sh. Hari Prasad Meena, Ex-Administrative Officer, Guru Nanak Eye Centre, Delhi vide his representation dated nil has alleged that Management of Guru Nanak Eye Centre are not paying the retirement dues and non granting MACP by the management in his favour.


2. NCST vide Notice dated 30.05.2024 had referred the matter to Secretary, Health & FW Department, GNCTD for furnishing the facts and comments within 30 days.

3. Guru Nanak Eye Centre vide letter no. 1(13)/GNEC/Estt./Complaint Comt./91)/H.S./3133-34 dated 20.07.2024 has furnished the facts and comments and stated that the petitioner has been asked to submit the requisite papers. As soon as received from the petitioner has sent to Pay & Account Office for authorization of pension on 08.07.2024. In case of MACP, it has also been sent to Service Department of 28.07.2024. In regards to MACP, the matter has been taken up with the Services Department, GNCTD on 15.07.2024

4. NCST has decided to discuss the issue with the Secretary, M/o Health and Family Welfare, GNCTD and petitioner on 29.11.2024 at 2:00 PM. The Sitting Notice was issued on 22.11.2024 for communicating the date and time of sitting. Guru Nanak Eye Centre vide email dated 28.11.2024 has forwarded a copy of the letter no. 1(19)/GNEC/Estt./2012/Part File-1/6948-49 dated 27.11.2024 and stated that the requisite papers have been submitted by the petitioner 26.11.2024. These papers will be processed. As far as MACP is concerned the matter is pending with the Services Department, GNCTD, New Delhi.

5. The Secretary, H & FW Department, GNCTD vide letter dated 29.11.2024 has deputed the Director, GNEC and Deputy Secretary, H&FW for attending the sitting. These officers were present but the petitioner was not present in the sitting on 29.11.2024.

6. The officers of GNEC has reiterated their earlier comments and stated that the matter will be processed for release of pension and granting of MACP. The officer of D/o H & FW, GNCTD stated that there is no role of the Department. The issue of the MACP relates with the services Department of GNCTD, New Delhi.

7. After the discussion with the Officers of GNEC, the following were recommended and action taken / to be taken thereon may be submitted to NCST within one month from the receipt of the minutes.

- The Services Department, GNCTD may be reminded by GNEC for granting of MACP in favour of the petitioner.
- The papers related to pension submitted by petitioner on 26.11.2024 to GNEC may be processed at the earliest.
- An Internal Grievance Redressal Committee may be set up in the GNEC and H & FW, Department, GNCTD, New Delhi to look after the grievances of ST employee, as advised by NCST in August, 2021 (copy enclosed).
- The petitioner is also advised to cooperate with the GNEC in respect of pension papers.
