Minutes of the sitting held under the Chairmanship of Shri Jatohu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi, in the case of Shri Shri R. Ramkishan, Administrative Officer, O/o Principal, Giriraj Government Degree College (A), Nizamabad regarding promotion to Deputy Director

Shri R. Ramkishan, Administrative Officer, O/o Principal, Giriraj Government Degree College (A), Nizamabad, vide his representation dated 21.03.2024, has alleged that the Higher Education Department promoted a person who does not belong to the concerned group, while the petitioner was not promoted. He stated that he has completed 27 years of service in the department and has only a few years left until superannuation. Hence, the issue may be examined, and justice be rendered by considering his promotion to the post of Deputy Director, which falls under the third point of the mufasil quota.

2. NCST vide notice dated 26.04.2024 had referred the matter to Principal Secretary, Higher Education, Govt. of Telangana, Hyderabad, (Telangana) for furnishing the facts and comments within 30 days. Higher Education, Govt. of Telangana vide letter dated 10.06.2024 has furnished the facts and comments and stated that the petitioner was the next Sr. most among the administrative officers in the GDCs after Shri Mohammad JavedPassa and the department has followed reservation rules. This reply was forwarded to petitioner on 26.07.2024 for information.

3. The Commission decided to discuss the issue with the authority and the petitioner on 25.11.2024 at 4:00 PM. Accordingly, the sitting notice was issued to Principal Secretary, Higher Education, Govt. of Telangana, Hyderabad, (Telangana).

4. In the sitting, the Joint Director, Higher Education Department, Govt of Telangana was present on behalf of Principal Secretary, Higher Education Department, Government of Telangana.

5. The petitioner informed his point of mufasil quota is not considered and his promotion is denied despite his several requests made to the authorities which are turned down. The issue is kept pending for long time.

6. The representative on behalf of the authority informed that the issue is being examined for necessary action.

7. After hearing all the parties, the Commission recommends the following and action taken report to be submitted within 30 days –

- The Principal Secretary, Higher Education may attend the next Scheduled Date of Hearing on 9.12.24 with complete details and Action Taken report.


