Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Manoj R. Sutaria, President, GUJREFIN Reserved (SC/ST/SEBC) Employees Welfare Association (GREWA) regarding injustice with ST Employees recruited by IOCL through special recruitment drive in 2017-2018.

Shri Manoj R Sutaria, President, GUJREFIN Reserved (SC/ST/SEBC) Employees Welfare Association (GREWA), Gujarat vide representation dated July, 2022 has alleged that the IOCL is not doing justice with the ST employees who were selected in the Special Recruitment Drive in 2017-2018 because of introduction of one year training period which was mandatory for ST employees. This delayed the date of joining, as well as date of promotion in future and caused financial loss. The Association raised the issue and it was discussed with Chairman, Parliamentary Committee on Welfare of SC and ST on 11.09.2018 and IOCL were directed to take necessary action (as stated by the petitioner). Further, it was informed by the petitioner that IOCL informed that their appointments would be from date of joining of training and not date of completion of training. But this has not been done in reality and petitioner alleges intentional delay which caused 4 months or later date of joining. This has caused loss of promotion on time and financial loss as well.

- 2. A sitting was held in NCST on 20.03.2023, in the sitting following recommendations were made –
- 1) The joining date of all the ST Candidates along with the date when they were moved to regular pay scale.
- 2) The details regarding the visit of Parliamentary Committee on Welfare SCs and STs to IOCL on 11.09.2018(as referred by the petitioner) and a copy of orders/directions, if any.
- 3) The IOCL Management may consider the cut off date in June 2018 for confirmation of the ST candidates (after completion of training)".
- 3. IOCL vide its letter dated 06.04.2023 submitted Action Taken Report, which was forwarded to forwarded to petitioner on 26.04.2023. The petitioner vide his rejoinder dated 05.05.2023 has reiterated his submissions and requested for justice.
- 4. NCST decided to discuss the issue with the authority and petitioner on 16.10.2024. Accordingly, sitting notice was issued on 09.10.2024 to Chairman, Indian Oil Corporation Limited, New Delhi and petitioner was also informed. The Chairman, IOCL vide letter dated 15.10.2024 had deputed Executive Director, (HR), IOCL to appear before the Commission on his behalf.

- 5. Executive Director, (HR), IOCL along with other officials and petitioners were present in the Sitting. The officials of IOCL reiterated that their earlier submissions. The petitioners stated that IOCL had already regularized them before completion of one year, hence, the date of joining may be declared from June, 2018.
- 6. The NCST observed that IOCL has reduced the joining period from one year to nine months in favour of the ST candidate recruited under Special Recruitment Drive (SRD). NCST discussed the issue with the officers and petitioners in the Sitting held on 20.03.2023. The reply submitted by IOCL was not satisfactory for NCST in the interest of ST employees, who performed well.
- 7. After discussion with the officers of IOCL and petitioner(s), the following was recommended and suggested to submit the Action Taken Report within 30 days from the receipt of the minutes –
- 1. IOCL may explore giving relaxation for three months to the petitioners (Total Nine (09) ST candidates of Gujarat Refinery who have been recruited through SRD) in next promotion. This will encourage the ST candidates to perform well in the interest of organisation.
- 2. TA and Special Leave may be reimbursed/granted in favour of all candidates who attended the Sitting.
- 3. The composition of Internal Grievance Committee setup in IOCL (as suggested by NCST in August, 2021 to all ministries/departments) to look-after the problems of ST employees, may be provided.
