Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, regarding discrepancies and delay in his promotion of Shri B. Babu, Joint Director of Horticulture, O/o Directorate of Horticulture, Hyderabad.

- Shri B. Babu, Joint Director of Horticulture, O/o Directorate of Horticulture, Hyderabad vide his representation dated 24.04.2024 has alleged that management of Department of Horticulture, Govt. of Telangana is not following the reservation and promotion rules properly. The petitioner's name was included in the 2010-11 panels for promotion under the ST carry-forward vacancy (Roster Point 25), but the vacancy was filled with a general category candidate, violating the rules for ST representation. The petitioner argues that G.O.Ms. No. 2 (2004) mandates filling ST carry-forward vacancies with eligible ST candidates, which was not followed in this case, leading to a loss of opportunity and morale for ST Officers.
- 2. NCST vide notice dated 30.05.2024 had referred the matter to APC and Principal Secretary (Horticulture), Department of Horticulture, Govt. of Telangana, Public Garden, Nampally, Hyderabad, (Telangana) for submitting facts and information within 30 days.
- 3. The Department of Horticulture, Govt. of Telangana vide their reply dated 10.07.2024 informed that the Rule of Reservation (R.o.R.) is being followed as per G.O. and court orders in the Department and no discrimination has been done with the petitioner.
- 4. The Commission decided to discuss the issue with the APC and Principal Secretary (Horticulture), Department of Horticulture, Govt. of Telangana and the petitioner on 17.10.2024. Accordingly, a Sitting Notice was sent on 07.10.2024 to concerned officers and petitioner.
- 5. The APC and Principal Secretary (Horticulture), Department of Horticulture, Govt. of Telangana vide his letter dated 15.10.2024 requested exemption from personal appearance and deputed Director of Horticulture, Department of Horticulture, Govt. of Telangana to appear on his behalf. The petitioner was present.

- 6. In the sitting, the Director reiterated the earlier comments of the Department and stated that rules have been applied uniformly to all and no discrimination had been done with the petitioner. The petitioner however claimed that he should have been promoted in 2010-11 panel and claimed retrospective promotion.
- 7. After hearing both the sides, the following was recommended and suggested to submit the Action Taken Report within 30 days from the receipt of the minutes –

 The Department of Horticulture, Govt. of Telangana to re-examine the case of the petitioner, as per rules.
