The General Secretary, All India Central /PSUs and State Government ST Employees Welfare Association, Central Executive Committee, Ananthapuramu vide representation dated 25.06.2024 has alleged that the ST employee (namely Shri T. Bhaskar, Dy. Director, APGLID, Ananthapuramu) is being harassed by the Directorate of Insurance (APGLID) by not considering him for the promotion to the post of Joint Director, APGLI.

2. NCST vide Notice dated 25.08.2024 had referred the matter to Chief Secretary, Govt. of Andhra Pradesh, Guntur for furnishing the facts and comments within 15 days from the receipt of this Notice. But No reply was received from the concerned authority.

3. The Commission had decided to discuss the issue with the Chief Secretary and petitioner on 7.11.2024 at 4:40 PM. Accordingly, a sitting notice was issued to concerned authority and petitioner on 24.10.2024.



4. The Director, APGLI and petitioner attended the sitting. In the sitting, the Director, Directorate of Insurance, Govt. of Andhra Pradesh, Mangalagiri, Amaravati had reiterated the earlier comments submitted to NCST vide its letter no. FIN04-12/11/2024/2575030-ADMN2Sec-DOID dated 4.10.2024. The petitioner alleged that in the Hon'ble High Court of Telangana in its decision dated 23.07.2023 in WP no. 35653 of 2022 had held that "writ petition is disposed of with liberty to the petitioner to assail the final seniority list dated 23.12.2022 in accordance with law, in case petitioner is aggrieved".

5. After the discussion with the officer and petitioner, it was recommended that the Govt. of Andhra Pradesh (Directorate of Insurance) may re-examine the issue, keeping in view of the judgements of Hon'ble High Court. The action taken/to be taken may be submitted to NCST within 30 days from receipt of the minutes.
