The State General Secretary, All India Banjara Seva Sangh, Ananthapuramu vide representation dated 23.06.2024 has alleged that the ST candidate (namely Shri K. Prabhakar Naik) is not being considered by APSPDCL for the post of Shift Operator. It is alleged that ST Candidate namely Kethavath Prabhakar Naik, who has studied ITI in Wireman Trade has applied for the post of Shift Operator and got listed in the merit list & qualified. But the Superintending Engineer, APSPDCL, Ananthapuramu is not considering his candidature and refused on the plea that he does not possess the Qualification in ELECTRICAL TRADE as he possess the Qualification in WIREMAN TRADE.

2. NCST vide Notice dated 25.08.2024 had referred the matter to Chairman & Managing Director, APSPDCL for furnishing the facts and comments within 30 days from the receipt of this Notice. But No reply was received from the concerned authority.

3. Hence, the Commission decided to discuss the issue with the Chairman & Managing Director, Southern Power Distribution Company of A.P. Limited, Tirupati and petitioner on 7.11.2024 at 4:20 PM. Accordingly, a sitting notice was issued to concerned authority and petitioner on 24.10.2024.

4. The Chairman & Managing Director, Southern Power Distribution Company of A.P. Limited, Tirupati vide letter dated 5.11.2024 has sought exemption and deputed Deputy General Manager, APSPDCL, Tirupati to attend the sitting.



5. The Deputy General Manager, APSPDCL, Tirupati and the petitioner had attended the sitting. The officers of APSPDCL informed that the said post is filled up through outsourcing. The petitioner was unable to provide the copy of the Advertisement of the said post.

6. After discussion with the officers of APSPDCL and petitioner, it was suggested APSPDCL and petitioner may provide a copy of the Advertisement for examination within a month.
