## National Commission for Scheduled Tribes

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri K Satheesh Naik, Ex- Shift Operator, APSPDCL regarding harassment of ST Employees.

The General Secretary, All India Central /PSUs and State Government ST Employees Welfare Association, Ananthapuramu vide representation dated 24.06.2024 has alleged that the ST employee (namely Shri K Satheesh Naik, Ex- Shift Operator, APSPDCL) is being harassed by the management of APSPDCL. He was working on contract and it was alleged that due to some negligence another Shift Operator got electric shock and died. Thereafter the APSPDCL asked the contractor to remove the Petitioner from the post in 2015. On 02.12.2016, Additional Judicial Magistrate, 1st Class, acquitted the petitioner under IPC 304A and found him not guilty. Thereafter he has requested the APSPDCL for reinstatement but the authorities have stated that Court has acquitted him but not directed for reinstatement.

- 2. NCST vide Notice dated 25.08.2024 had referred the matter to the Chairman & Managing Director, APSPDCL for furnishing the facts and comments within 30 days from the receipt of this Notice. But no reply was received from the concerned authority and petitioner till date.
- 3. The Commission had decided to discuss the issue with the Chairman & Managing Director, Southern Power Distribution Company of A.P. Limited, Tirupati and petitioner on 7.11.2024 at 4:00 PM. Accordingly, a sitting notice was issued to concerned authority and petitioner on 24.10.2024.
- 4. The Chairman & Managing Director, Southern Power Distribution Company of A.P. Limited, Tirupati vide letter dated 5.11.2024 has sought exemption and deputed Deputy General Manager, APSPDCL, Tirupati to attend the sitting.
- 5. The Deputy General Manager, APSPDCL, Tirupati and petitioner along with the petitioner (Shri K. Satheesh Naik, Ex-Shift Operator, APSPDCL) had attended the sitting.
- 6. The officers of APSPDCL had submitted a copy of the letter no. CMD/SPDCL/CGM-HRD/GM-HR/DGM-P&ADM/F.Outsourcing/D.No.488/2024 dated 5.11.2024 addressed to NCST. In the letter it has been informed that the petitioner has been allowed to join the duty as Field Assistant on 24.10.2024, with old wages of Rs 23,500/- per month, though the Energy Department has issued instructions in Lr. No. ENE01-OPCS/1/2020 dated 1.08.2020 to pay the new wages of Rs. 18,500/- per month to Shift Operators/Field Assistants. The information furnished in this letter was reiterated and stated that the department has taken corrective action and requested to close the case.

- 7. The petitioner reiterated his earlier submission and stated that copy of Logbook may be asked from the authority for justification.
- 8. The NCST observed that the petitioner request has been resolved by the APSPDCL, Tirupati. The present case belongs to outsourcing job. Hence, no further action is warranted on behalf of NCST.
- 9. After discussion with the officers of APSPDCL and petitioner, it was suggested that APSPDCL may provide the copy of the Logbook for examination within a month.
