Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi, in the case of Shri G. Ramesh, National Vice President of the All India ST Employees Association regarding unfair chargesheet and transfer.

Shri G. Ramesh, National Vice President of the All India ST Employees Association, alleges harassment by SCCL management (previous CMD) through unfair transfers, baseless charge sheets, and requests redressal by dropping for unfair charge sheets and transfer back to headquarters for family and medical reasons.

- 2. The NCST vide letter dated 25.08.2024 had referred the matter to CMD, Singareni Collieries Company Ltd. (SCCL), Kothagudem Collieries, BhadradriKothgudem (Telangana) and requested to furnish the action taken/ to be taken within 30 days.
- 3. Since no reply was received, the Commission decided to discuss the issue with the authority and the petitioner on 25.11.2024 at 12:40 PM. Accordingly, a Sitting Notice was sent on 18.11.2024.
- 4. In the sitting, the CMD, Singareni Collieries Company Ltd. (SCCL) was personally present and the petitioner was also present.
- 5. In the sitting, the petitioner informed that SCCL management is harassing for representing on behalf of ST employees and without considering his representation on health grounds has not been considering the transfer to Hyderabad.
- 6. The CMD has stated that as per the transfer is being considered as per the transfer policy of SCCL .
- 7. After hearing both the sides, the Commission recommends the following and action taken report to be submitted within 30 days
  - The Deputation may be considered for 3 years time for Shri Ramesh as Professor of Practice with further scope of extension.

The charge sheets on the petitioner may be re-examined and dropped.
