Subject: Representation dated 5.8.2021 from Shri B. Prasad Naik, General Secretary, Union Bank of India ST Employees Welfare Association, Hyderabad regarding holding statutory grievances redressal meetings with ST associations.

Sir,

I am directed to refer to National Commission for Scheduled Tribes (NCST) letter No. NCST-17012(MFIN)/35/2021-RU4 dated 03.12.2024 and the discussions held during the sitting on 09.12.2024 on the subject mentioned above.

- 2. In this regard, the submissions of this Department are as under:
  - i. NCST vide its minutes dated 22.07.2024 has recommended the following:

"The guidelines dated 22.08.2013 issued by the Department of Financial Services in respect of holding of meetings with the Employees Welfare Associations may be modified accordingly so that the ST Employees Welfare Association may participate in the meetings with the management separately. Department of Financial Services may initiate action in this regard within 30 days."

ii. Accordingly, in line with the recommendations of NCST, the DFS guidelines/instructions dated 22.08.2013 has been revisited and a revised draft guidelines/instruction for holding of quarterly meetings with the ST Employees Welfare Association has been shared with the various stakeholders such as IBA, GIPSA, PFRDA, IRDAI and RBI for their comments vide DFS letter dated 22.08.2024. The comments of these stakeholders received in the Department (except IRDAI).

iii. NCST vide it minutes dated 29.11.2024, has recommended the following:

"DFS may expedite the process of formulating the guidelines, as recommended in the previous sitting and suggested to submit the Action Taken Report within 30 days from the receipt of the minutes"

- iv. During the examination, it was felt that the matter which involves not only Public Sector Banks (PSBs) but also Public Sector Insurance Companies (PSICs), Public Financial Institutions (PFIs) etc., and involves other Ministries/Departments. Therefore, the comments of M/o Social Justice and Empowerment and Ministry of Tribal Affairs have been sought vide O.M dated 28.11.2024 and 10.12.2024. The comments/replies of M/o Social Justice and Empowerment and Ministry of Tribal Affairs are yet to be received.
- v. The revised guidelines/instructions will be applicable to the all the PSBs, PSICs, PFIs and Regulators. It would be important to include the views/comments of these stakeholders including nodal Central Ministries/Departments so that a comprehensive guidelines/instruction may be issued.
- 3. In view of above submissions, finalization of the revised guidelines/instructions needs holistic examination and require some more time. Hence, Hon'ble, NCST is most humbly requested that adequate time may please be given so that proper consideration can be taken in the matter.
