1. The Commission has received a complaint through email on 01.12.2023 from Shri Arun S Hirehal, Dharwad alleging that Shri Basavaraj S Horatti being an elected representative of SarvodayaShikshana Trust misused his powers and influenced the officers to get his name into the Trust during 2009. He has forged/fabricated records to get hold of SarvodayaShikshana Trust during the year 2009 illegally and moved ahead to own the assets of the trust but all rights of trust was transferred to Shri R.N. Pujar(member of scheduled Tribes) and had been declared sole trustee by original founder of the trust Shri Dabade. Petitioner further stated that SarvodayaShikshana Trust supposed to provide benefit to many tribal people but because of accused it has led to the economic boycott of scheduled Tribes / Tribes of Karnataka. Karnataka state Police has not registered the complaint under SC /ST atrocity act. Petitioner requested to Commission to intervene in the matter and give direction to the concerned authority.
2. The Commission has sought a report within 15 days from the Director General of Police, Karnataka, Bangalore NCST's vide Notice dated 11.01.2024.
3. In response to NCST's notice dated 11.01.2024, the SP Dharwad has submitted a report dated 21.2.2024 to NCST and the same was sent to the petitioner on 14.03.2024, the petitioner was not satisfied with the reply received from concerned Department and filed a rejoinder on 09.04.2024 which was forwarded to the SP Dharwad on 04.06.2024 by the NCST for further action taken report on the same within 15 days. Further report from SP Dharwad received on 25.07.2024 was forwarded to the petitioner on 02.09.2024 but the petitioner was not satisfied with this report,hence commission has decided to have a discussion with the Director General & Inspector and Superintendent of Police and the petitioner on 11.12.2024.

5. Accordingly, the sitting notice was issued to all authorities and petitioner.
6. The Director General & Inspector General of Police, Govt. of Karnataka, Police Department vide letter No. L&O/2/19/2024 dated 07.12.2024 has apprised that Dr. Gopal M. Byakod, IPS, Superintendent of Police, District-Dharwad will attend the sitting on behalf of Director General and Inspector General of Police, Karnataka. The Hon'ble chair has granted the permission to SP, Dharwad to attend the sitting. Accordingly, the Superintendent of Police (Dr. Gopal M. Byakod, IPS), District-Dharwad, Karnataka has attended the sitting. The petitioner was not present in the sitting.

**Discussion:**

The petitioner over VC has informed that the trust originally formed by Sri Damde in 1956 and has 8 campuses of a total 40 acres and approximate value of over 60 Cr. Later on transferred to DK Naiker and RN Pujar in 1995 and Valmiki Mutt in 2003. It is alleged that Shri Basavaraj Horatti has fabricated the records when he was the Education Minister and he is illegally holding the trust. He is not having any valid declaration suit and is influencing the police Department to close the complaint. Further, he is running trust from his home, recruiting his own people for all the posts of this Government aided school and making money.

The authority has submitted that the civil dispute is pending at District Court and it asked the District collector to rehear the matter. As the allegation is against Sri Basavaraj Horatti who is currently the Hon'ble Chairperson of Karnataka State Legislative council, unless there is a concrete evidence the police could not register any case against him.

**Recommendations:**

1. The Registrar cooperative society and Sub Registrar to attend the hearing with Registration document and complete details on the next hearing date.
2. The DG and IG of the police may attend on the next hearing date.


