Minutes of the Sitting held on 11.12.2024 at 04:00 P.M. under the chairmanship of Shri Jatothu Hussain, Hon'ble Member, NCST in the case of Shri M. Mallaiah, President of Telangana Scheduled Tribe Employees Association, House No.74, Hig Phase 3, Annamayya Enclave Bhel, Ramachandrapuram, Hyderabad, Telangana (Mob No:8755167893).

- The Petitioner vide letter dated 23.03.2024 had made a complaint to the Commission mentioning that Gudivada village secretary and his assistant stopped Mr. KonetiNarsaiah S/o. China Bhadraiah of Gudivada village, from digging bore well. He has alleged that SI and other police authorities have taken Mr. KonetiNarsaiah into custody without registering FIR and beaten up him mercilessly. In this connection he requested Commission to intervene in the matter.
- The Commission has sought a report within 15 days from the Superintendent of Police, Nalgonda vide Notice dated 20.05.2024.
- In response to NCST's notice dated 20.05,2024, the Superintendent of 3. Police, Nalgonda has furnished their report vide letter dated 25.06.2024 and the same wasforwarded to the petitioner on 02.09.2024, the petitioner was not satisfied with the reply received from Superintendent of Police, Nalgonda and filed a rejoinder on 18.09.2024and requested the Commission to issue Summons to the Superintendent of Police, Nalgonda and to conduct a detailed review of the case in the interest of justice. Therefore, the Commission has decided to hold a sitting on 11.12.2024 in this matter.

- Accordingly, the sitting Notice was issued on 04.12.2024 to the Superintendent of Police, Nalgonda.
- On the day of sitting (i.e. 11.12.2024 at 04:00 P.M.), none was present from the concerned Department. The petitioner was present in the sitting.
- The petitioner has informed that Sri. Koneti Narsiah was unlawfully 7. taken into custody and tortured in police Station for no reason.

Recommendations:

The SP, Nalgonda may attend the hearing scheduled on 6.1.2025 with a detailed report of incident and the custodial torture of Sri.Koneti Narsiah in Kethipally Police Station.
