**SITTING NOTICE**

**Sub:** Representation dated 22/08/2014 received from Shri Bharat Lal Meena, S/o Shri Ram Narayan Meena, Village Khori Dhadi, Ramnath Patel Ki, Post Banskoh, Tehsil Bassi, District Jaipur, Rajasthan regarding re-medical examination for the post of Assistant Station Master.

Sir,

Whereas the Commission held a sitting on 05/07/2017 on the subject mentioned above and as per discussion in the sitting the matter was referred to the Director, AIIMS, New Delhi for re-medical examination of Shri Bharat Lal Meena vide this Commission's letter dated 11/08/2017.

2. Whereas in response to the Commission's letter dated 11/08/2017 Dr. Rajendra Prasad, Centre for Ophthalmic Sciences, AIIMS, New Delhi has intimated that Shri Bharat Lal Meena, age 29 year / Male, S/o Shri Ramnarayan Meena, Village Khori Dhadi, Ramnath Patel Ki, Post Banskoh Tehsil Bassi, District Jaipur, Rajasthan presented himself on 24/08/2017 and examined by the Members of Medical Board of AIIMS, New Delhi. On examination, it is found that "his unaided visual acuity was right eye (RE) 6/6 and left eye (LE) 6/6 and near vision was N6 in each eye. His colour vision on Ishihara chart and Edridge-Green Lantern test was within normal limit. His orthoptic evaluation was within normal limits. His anterior segment and posterior segments were within normal limits".

3. The Commission has taken serious note of the continued harassment meted out to a young ST aspirant for Public Service.

4. Shri Nand Kumar Sai, Hon'ble Chairperson, NCST has desired to discuss the matter in person with you in the Commission on 10.11.2017 at 12:00 noon for investigation/inquiry/ action to be taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India.

5. You are requested to kindly make it convenient to attend the Sitting in Commission in person on the scheduled date and time and submit the facts and action taken on the matter referred to in the press report/petition/representation.

6. Further, it is requested to bring all the relevant records/files in the matter for placing before the Commission as would be necessary during the Sitting.

Please take notice that in case of failure to attend the Sitting, the Commission will be constrained to exercise the powers of civil court conferred on it under Clause (8) of Article 338A of the Constitution of India and issue summons for the appearance in person before the Commission.
